Pursuant to Public Utilities Code §314 and Rules 1.1 and 10.1 of the California Public Utilities Commission's (CPUC) Rules of Practice and Procedure, the CPUC Communications Division requires a response to this data request from all service providers registering with the California Teleconnect Fund (CTF) Program or updating the information requested herein.

The CTF is a Public Purpose Program administered by the CPUC pursuant to Public Utilities Code § 280(a). The CTF Program subsidizes advanced communications services for participating organizations, including schools, community colleges, libraries, hospitals, health clinics, and community-based organizations. For additional information on the CTF Program visit www.cpuc.ca.gov/ctf.

Service providers facilitate CTF subsidies by applying a 50% discount on eligible services within CTF participants' monthly bills. After applying the discount, service providers submit claims for reimbursement to the CPUC Communications Division. Service providers must register with the CTF Program prior to offering discounts and submitting claims for reimbursement. Service providers must provide an updated response when any of the requested information changes. To request registration or update information, a service provider must submit a response to this data request to CTFClaims@cpuc.ca.gov.

- 1.2) Will You file claims for reimbursement from the CTF Program directly to the CPUC Communications Division or will another company file them on your behalf? Provide the requested information according to the following instructions:

- In cell A1 type the header: "Product Name." In column A, under the header, list the marketed name of the service. Enter this information in text format.

- In cell B1 type the header: “Eligible Service.” In column B, under the header, identify the CTF Eligible Service that corresponds to the Product listed within the same row in column A. Enter only one CTF Eligible Service. Enter this information in text format. Valid entries are limited to the following: ATM, BPL, Cable, DSL, Digital, Ethernet, Fiber, Frame, ISDN, Mobile, Optical, Satellite, SMDs, Trunk, WAN, or Wireless. These valid entries correspond to the following descriptions:
 - ATM = Asynchronous Transfer Mode
 - BPL = Broadband Over Power Lines
 - Cable = Cable Modem
 - DSL = Digital Subscriber Line
 - Digital = Digital Signal, DS1, DS2, etc.
 - Ethernet = Ethernet
 - Fiber = Fiber Optics
 - Frame = Frame Relay
 - ISDN = Integrated Services Digital Network
 - MBS = Mobile Broadband Service
 - MPLS = Multi-Protocol Label Switching
 - Optical = Optical Carrier, OC1, OC2, etc.
 - Satellite = Fixed Satellite
 - SMDs = Switched Multimegabit Data
 - Trunk = Trunk Level, T1, T2, etc.
 - WAN = Wide Area Network
 - Wireless = Fixed Wireless
- In cell C1 type the header: “Max Download Speed.” In column C, under the header, list the maximum advertised download speed, in units of megabits per second, that corresponds to the Product listed within the same row in column A. Enter this information in number format.
- In cell D1 type the header: “Max Upload Speed.” In column D, under the header, list the maximum advertised upload speed, in units of megabits per second, that corresponds to the Product listed within the same row in column A. Enter this information in number format.
- In cell E1 type the header: “Max Cost.” In column E, under the header, list the monthly recurring cost of the product listed within the same row in column A. If the monthly recurring cost of the product varies per customer, enter the highest monthly recurring cost charged to customers. Enter the monthly recurring cost prior to any discounts or promotions. Enter this information as in currency format.
- In cell F1 type the header: “Min Cost.” In column F, under the header, list the monthly recurring cost of the product listed within the same row in column A. If the monthly recurring cost of the product varies per customer, enter the lowest monthly recurring cost charged to customers. Enter the

monthly recurring cost prior to any discounts or promotions. Enter this information as in currency format.

- In cell G1 type the header “CTF Dedicated Webpage.” In column G, under the header, include the URL for the service providers CTF dedicated webpage. Enter this information in text format. The webpage must include the following information: CTF-eligible service information included in the report, a list of all CTF-eligible products offered with pricing information, download speeds, and CTF contact information.

Max Download Speed	Maximum data download speed in Mbps.	NNNN	1000	Enter the maximum advertised download speed in Mbps.
