AUDIT SUMMARY

Company: SDG&E - Northeast District

G.O. 95 & 128 Audit

Date: October 25 – 29, 2010

The following violations were observed:

1. GO 95, Rule 54.6B: Ground Wires

"... That portion of the ground wire attached to the face or back of wood crossarms or on the surface of wood poles and structures shall be covered by a suitable protective covering (see Rule 22.8)."

Pole 614515 had damaged ground moulding. This was not documented by SDG&E when it inspected the pole on 5/14/10. This violation was repaired during the audit.

2. GO 95, Rule 35: Tree Trimming

"Where overhead wires pass through trees, safety and reliability of service demand that tree trimming be done in order that the wires may clear branches and foliage by a reasonable distance..."

Pole 212087 – a tree branch was straining a supply service conductor. This was not documented by SDG&E when it inspected the pole on 5/20/10. This violation was repaired during the audit.

3. GO 95, Rule 54.7: Climbing and Working Space

"Climbing space shall be maintained from the ground level. Climbing space, measured from center line of pole, shall be provided on one side or in one quadrant of all poles or structures with dimensions as specified in the following..."

- Pole 130862 had a communications company box in the climbing space. This
 was not documented by SDG&E when it inspected the pole on 6/7/10.
- Pole 117761 had a communications conductor in the climbing space. This
 was not documented by SDG&E when it inspected the pole on 5/21/10.
- 3) Pole 518263 had a communications company ground wire (not suitably protected) in the climbing space. This was not documented by SDG&E when it inspected the pole on 5/17/10.
- 4) Pole 718223 had a communications conductor in the climbing space. This was not documented by SDG&E when it inspected the pole on 5/11/10.
