The attached sheets demonstrate the status of 1998 Inspections and Corrections in the state of California for PacifiCorp owned facilities. PacifiCorp has four districts in California: Tulelake, Alturas, Crescent City and Yreka/Mt. Shasta.

Inspections

All inspections were completed in 1998 for Urban & Rural Patrol, Detail and Intrusive inspection types. All Districts, except Crescent City, have chosen to upgrade to the Urban plan for their Rural areas, this is reflected by a NA in the attached sheets. The attached Inspection sheets break down the inspections into three categories: Poles, Street Lights and Equipment. The information includes the type of equipment, the plan for each inspection category and the actuals of the inspection plan.

Conditions

Conditions found by the inspections were rated as either an A or B priority, A priority being more severe. All A priority conditions found by the inspections have been corrected except for 16. These conditions are in a very inaccessible location. Each structure requires hand digging, rock holes, and placement by helicopter. Because of the location, these facilities do not create a public, or employee hazard. These structures will be replaced before July 30, 1999. The remaining B priority conditions will be corrected by year-end 2000. The attached Condition sheets breakdown the conditions into four categories: number of conditions found in 1998, 1998 conditions corrected as of 6/28/99, 1998 conditions currently outstanding, and the final date outstanding conditions will be corrected by.
