Narrative: This SQRU encompasses that portion of Shavers Valley extending approximately 1.5 to 2 miles north and south of Interstate 10 (I-10) between the Cactus City Rest Stop and Chiriaco Summit. The valley bottom is flat and relatively non-descript with low growing grasses and shrubs. Distant, rugged mountain ridgelines (not part of the unit) define much of the horizon and provide a backdrop to much of this unit. SQRU 04 is transected by several noticeable built features including I-10 down the middle of the valley, transmission lines on both the north and south sides of the freeway, utility pole lines and fences, and local roads (Box Canyon Road to the south and Cottonwood Springs Road to the north. This portion of Unit 04 is more influenced by the close proximity of a transmission line than that portion represented by Viewpoint 6.
