INTRODUCTION

I

This report provides a summary of the construction and compliance activities associated with the SCE DPV2 Transmission and Red Bluff Substation Projects:

A summary of the Notices to Proceed (NTPs) with construction and Variance Request activity are also provided (see Tables 1 and 2, respectively, near the end of this report). Additionally, a summary of Temporary Extra Workspace Requests (TEWS) is provided in Table 3.

CPUC/Aspen Environmental Monitors (EM): Jamie Miner was on site September 21 and 22.

CPUC NTPS

DPV 2 CONSTRUCTION AND MATERIAL YARDS

NTP #1 was issued for construction and set-up of construction yards, including the Devers, Desert Center 1 (DC1), Desert Center 2 (DC2), Blythe, Beaumont, Menifee, and Perris Construction Yards.

Summary of Activity:

- 1. Major construction activities associated with yard development were limited to the Devers and Perris Construction Yards during the subject period. Activities that were conducted at the Devers Yard included fence and wind screen installation, gravel spreading, equipment mobilization, and removal of BMPs (see Figures 1 and 2). Additionally, minor road improvements were performed at the offsite TEWS water location per approval from CPUC EM on September 15, 2011 (see Figure 3). Construction activities were initiated at the Perris Construction Yard on September 19, and included BMP installation, vegetation clearing, gravel placement, and completion of fence installation.
- 2. Activities that occurred at the DC1 and DC2 Construction Yards were limited to the installation of wood power poles and power supply.
- 3. A small crew was onsite at the Beaumont Construction Yard to conduct hydroseeding and installation of jute netting per approved Variance #8 (see Table 2).

Environmental Compliance:

- 1. On September 21, the SCE EM informed the CPUC EM that he had identified that silt fencing around the Devers Yard exhibited areas that would need repair due to small holes. SCE EM informed CPUC EM that the repairs would be performed over the next couple of days.
- 2. On September 22, a worker operating the front-end loader at the Perris Construction Yard notified the SCE Biological Monitor that he had cut the tail of a gopher snake. The injured snake was relocated to adjacent habitat just offsite by the Biological Monitor.
- 3. Throughout the subject period, SCE monitors reported that BMPs were in functioning condition, secondary containment areas were adequate, dust suppression was applied, trash was removed, and speed limits were obeyed at all construction yards where activities occurred. The CPUC EM noted proper signage installed at drainages along access road to Devers Construction Yard (see Figure 4).

4. On September 22, the CPUC EM identified a large drum of fluid that had been left uncovered at the Perris Construction Yard. A construction worker stated that he was going to replace the lid immediately (see Figure 5).

DPV2 EXCLUSIONARY FENCING AT 41 TOWER LOCATIONS

NTP #2 was issued by CPUC for the installation of Coachella Valley fringe-toed lizard (*Uma inornata*) and flat-tailed horned lizard (*Phrynosoma mcallii*) exclusionary fencing at 41 tower locations between the Devers Substation and Indio.

Summary of Activity:

1. During the subject period, exclusionary fencing activities were completed at three locations, including Towers #2211, #2241, and #2242. These activities included trenching and installation of fencing (see Figures 6 and 7).

Environmental Compliance:

- 1. The SCE Biological Monitor reported several events in which wildlife species, including desert iguana and side-blotched lizard, were relocated to adjacent habitat throughout the subject period; however, no special-status species were observed.
- 2. CPUC EM noted that drip pans were installed under stationary water trucks that were being used during trenching activities (see Figure 8).

BEAUMONT #2 CONSTRUCTION YARD

NTP #3 was issued for construction activities associated with the development of the Beaumont #2 Construction Yard.

Summary of Activity:

1. No activities associated with NTP #3 were conducted during the subject period.

INDIO CONSTRUCTION YARD

NTP #4 was issued for construction activities associated with the development of the Indio Construction Yard.

Summary of Activity:

1. No activities associated with NTP #4 were conducted during the subject period.

BLM NTPS

RED BLUFF SUBSTATION

BLM NTP #1 and a Right-of-Way grant were issued by BLM on September 19, 2011 for construction of the Red Bluff Substation and the Desert Center Communication Site.

Summary of Activity:

1. Activities associated with the Red Bluff Substation were limited to staking of the eastern and northern wall locations and flagging of a possible secondary well located on the west side of Corn Springs Road near the crossing at Chuckwalla Valley Road.

Environmental Compliance:

1. WEAP training was implemented for all workers present at the Red Bluff Substation work site. Training included discussion of maintaining speed limits, inspecting parked vehicles and equipment for desert tortoise, washing vehicles prior to entering work sites, notifying appropriate monitors in the event that resources arise, etc.

No Non-Compliance Reports (NCRs) or Project Memoranda (PM) were issued for construction activities during the subject period.
