Re: PG&E Jefferson-Martin 230 kV Transmission Project

Dear Ms. Blanchard:

We are parents of children who attend Highlands Elementary School in the San Mateo Highlands. Highlands Elementary School is just one short half block east of Lexington Avenue, a street along which PG&E proposes to build its Transmission Project.

We are very concerned for the safety of our children, and ask that you **DO NOT ALLOW THE ABOVE-GROUND CONSTRUCTION** of large towers that will carry four times the present power. We are concerned about the health risks that accompany such an increase in Electric and Magnetic Field emissions.

Our children, who spend over seven hours a day near these transmission lines, will receive no benefit from the project. They should not be forced to bear the health risks associated with it, nor should they be subjected to the classroom disruption, congestion and air pollution that will occur as a result of construction, earthmovers and overhead helicopters.

We urge you to consider the "NO PROJECT ALTERNATIVE". Since PG&E relied on outdated data in projecting future demand for electricity, the projected need is clearly overstated due to recent years' downturn in the economy and the dot-com bust.

Even if PG&E is able to show a great need for electricity in San Francisco, we urge you to require PG&E to generate the power locally, in San Francisco. It is far more efficient, not to mention fair.

If there is no way to avoid the increase in transmission of these lines, we ask that you **PROPERLY UNDERGROUND** the lines, so that the magnetic fields will be significantly reduced.
