INTRODUCTION

During the week of 12/12/2010 through 12/18/2010, construction continued at the Alpine RFO, Alpine Construction Yards, San Luis Rey Substation, the Rough Acres Construction Yard, the Thomas Yard and Link 4 Underground. Notice to Proceed No. 11, Link 3, Suncrest Substation, was issued on 12/15/2010. Authorization to Proceed was submitted on 12/16/2010 and confirmation was received on 12/17/2010.

Pre-Construction Activity with appropriate monitors:

During the week of 12/13/2010 through 12/17/2010, crews worked staking and surveying construction yards:

Link 1: AER Construction Yard, one crew, one day; Jacumba Valley Ranch (JVR) Construction Yard, one crew, one day.

Link 2: Kreuzcamp Yard, one crew, three days; Bartlett/Hauser Creek Construction Yard, one crew, three days.

Link 5: Sycamore Estates & Helix Yard, one crew, three days.

ALL LINKS

The following is a summary of construction activity where monitors were on site:

Alpine RFO: Minimal contractor activity on site primarily for the PAR office modular office. An enclosed guard shelter was installed and a street light at the main entrance. All activity was monitored by Link Leads and storm water monitors.

Alpine Construction Yard: Equipment and reel deliveries continued.

San Luis Rey Substation: On Friday, December 17, 2010, the 230kV shunt capacitor bank and circuit breaker installation was successfully completed and energized. Work continues in the 69kV yard continues.

Rough Acres Construction Yard: PAR has moved the tower bridge assembly used during the Groundbreaking Ceremony to the end of the air strip and has begun full tower assembly. Inventory of steel continues within the storage barns. Delivery of reels continues.

Encina Switchyard: No ground disturbing work being conducted. Only SDG&E on site to build and test disconnects. The next contractor to conduct Sunrise work will be Roel and they are not expected to begin set-up and construction until possibly January 3, 2011.

Thomas Yard: No delivery of material this week. It was agreed that a monitor was not needed on site because no ground disturbing activity is taking place and the Link Lead is on site. The Link Lead continues to monitor the Burrowing Owls. On 12/14/2010, a protocol-level Burrowing Owl survey was conducted at the Thomas Yard.

Link 4 Underground: Daily three and four crews were working Link 4, on Alpine Blvd. Vault 18 was set on December 14, 2010 and closed-up by 12/16/2010. Carpooling was conducted by Sunrise Project staff to view setting of the first section of the vault. Excavation and shoring was started for Vault 15. Pot-holing activity continued between station 279 and 224. Pot-holing also occurred near Vault 9 and Vault 13.

On Friday, 12/17/2010, the only crew on the ROW was working at Vault 15 to install additional shoring. Other crews not released because of forecasted rain. Saturday, 12/18/2010 scheduled work (Vault 18) was cancelled due to predicted rain and a meeting at the school which would not allow traffic control until after 11:30 a.m.

Pre-construction surveys were conducted between Vault 14 and Tavern Road and released for construction.

Pre-construction surveys were conducted on the Bauer property and released for tree trimming and geo-technical boring activities.

Link 3 Suncrest Substation: Subcontractors began vegetation removal in areas cleared for construction; BMPs were installed, Baker Tanks and water tank were set on site. This work was conducted near the Wilson gate.

SWEAP and Wildland Fire Prevention Training, continues to be facilitated at the Ayres Inn in Alpine every Tuesday and Thursday at 7:30 a.m.

During the reporting period of 12/12/2010 to 12/18/2010 a rain event occurred on 12/16/2010 with precipitation amounts of .10 of an inch at Alpine and Rough Acres. Trace amounts recorded in other areas. Another rain event began on 12/17/2010 through 12/20/2010 (Friday evening through Monday morning) with 1.8 inches recorded at the Encina Switchyard and 2 inches recorded at Alpine. On 12/20/2010, BMPs were inspected at all locations with no deficiencies. After a review of BMPs on Link 3, additional installation of fiber rolls will be conducted.
