
Thank you very much for your recent letter. Alternate Route D will go through Potrero. We have enclosed a corrected map of our area.

These large towers climbing over the hills and marching through the valley will be visible to most residents of Potrero.


The scoping process must include Potrero and the comment period needs to be extended so that Potrero residents will have the opportunity to respond once they get all the information on Alternate Route D, from you.

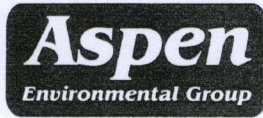

Dear Ms. Chamberlain and Ms. Simmons,

In response to your comment letters dated June 4 and June 8, I would like to put your concern at rest. The Sunrise Powerlink EIR/EIS will not include consideration of an alternative transmission line route passing through the Potrero area.

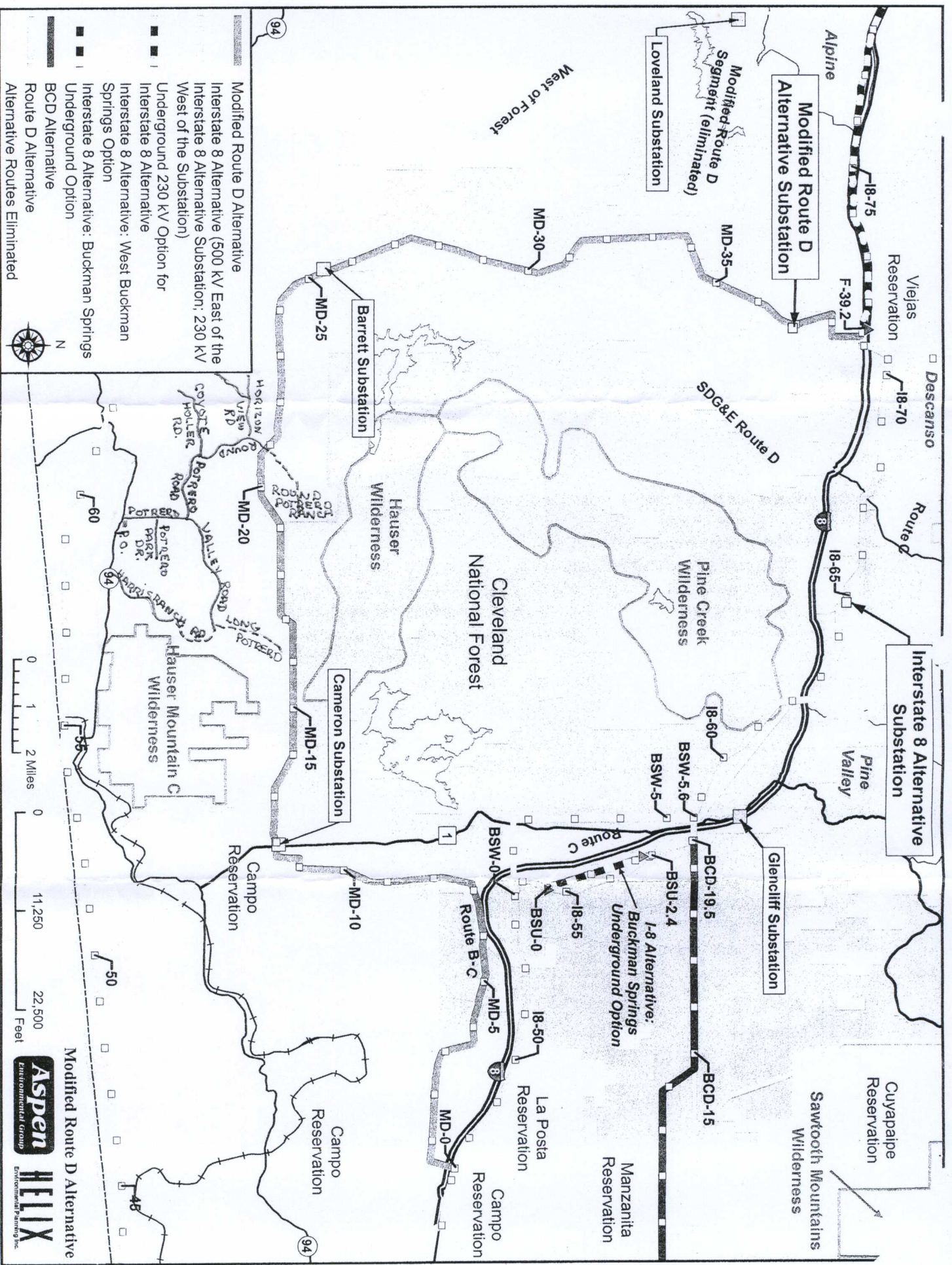
The notice letter you received in May 2007 regarding the Modified Route D Alternative included a map, enclosed here, depicting the alternatives under consideration and the alternatives eliminated. Our map legend failed to identify the orange line at the southern border as the *existing* SDG&E 500 kV Southwest Powerlink transmission line. Without this legend explanation, it could appear that a Sunrise Powerlink alternative following the existing Southwest Powerlink was under consideration. I apologize for the lack of clarity. The nearest alternative to Potrero is the Modified Route D Alternative, which would be located several miles north of Potrero.
