Final Environmental Impact Report/Environmental Impact Statement (EIR/EIS) for the Power Line Replacement Projects, July 2015

The California Public Utilities Commission (CPUC) and U.S. Forest Service published the EIR/EIS for the Master Special Use Permit and Permit to Construct Power Line Replacement Projects (Project) in June 2015. Following publication, SDG&E identified several minor errors, which are described below. These errata items clarify existing text in the EIR/EIS and do not raise new issues about significant effects on the environment. Such changes are insignificant as the term is used in Section 15088.5(b) of the California Environmental Quality Act Guidelines, and under the National Environmental Policy Act and do not result in new significant circumstances or information relevant to environmental concerns, nor do they require analysis of a new alternative (40 C.F.R. § 1502.9(c)(1)(ii)).

3.	B.5.2.1 Page B-40	Table B-7	The approximate quantity of TL625 fly yards outside CNF is listed as 5 but should be 4 according to the data response from SDG&E dated May 1, 2015.
4.	B.5.2.1 Page B-40	Table B-7	The approximate quantity of total TL625 fly yards is listed as 6 but should be 5 according to the data response from SDG&E dated May 1, 2015.
5.	B.5.2.1 Page B-40	Table B-7	The approximate area (acres) of TL625 fly yards outside CNF is listed as 8.5 but should be 7.4 according to the data response from SDG&E dated May 1, 2015.
6.	B.5.2.1 Page B-40	Table B-7	The total approximate area (acres) of TL625 fly yards is listed as 8.8 but should be 7.7 according to the data response from SDG&E dated May 1, 2015.
7.	B.5.4 Page B-59	Approximately 5–10 million gallons of water would be required on site during the construction of SDG&E's proposed project over the 5-year construction period.	This statement in the project description inadvertently omits the term "per year." The description of anticipated water use in the analysis of public services and utilities on page D.12-10 correctly includes this term. For consistency and accuracy, the statement in the project description should read: "Approximately 5–10 million gallons of water per year would be required on site during the construction of SDG&E's proposed project over the 5-year construction period."
