As discussed in the call, TEAM did not conduct the Second Quarter 2015 groundwater monitoring as anticipated and we apologize for this missed event. CMC Metals (0877887 BC Ltd) and TEAM worked through some administrative issues related to financial compensation during the quarter. This situation has been resolved, and TEAM plans to resume quarterly monitoring and reporting as specified in the Bishop Mill's WDRs. TEAM plans to conduct the third quarter monitoring event in August with the quarterly report submitted by October 30. After our call, I confirmed with CMC that the Bishop Mill remains inactive and that they continue to work towards achieving fully compliant operational status.
