Hey folks, we have identified an emerging issue.

The Contractor has been finding it very difficult to locate PM10 certified sweepers (see attached South Coast AQMD Cert Sweepers, as referenced in FEIR Section 2.3 Table 4.3-5). As of Friday, they had contacted four vendors that have all stated they do not have in their inventory any PM10 certified sweepers.

Currently, they have found only one certified sweeper from San Diego that they're bringing to the project site (Tymco 600).

As the project continues to look for certified sweepers, we are proposing to use SC8000 (see attached proposed sweeper) to supplement the fleet. The SC8000 is a rider scrubber that employs Dust Guard to suppress airborne fugitive dust.
