In accordance with Rule 11.6 of the Commission's Rules of Practice and Procedure, Southern California Edison Company, Southern California Gas Company, Pacific Gas and Electric Company, San Diego Gas & Electric Company, and the California Center for Sustainable Energy respectfully submit this motion seeking approval of a time extension for submittal of the Market-Focused Process Evaluation Report for the Self-Generation Incentive Program (SGIP). The joint parties to this motion are the Program Administrators (PAs) of the SGIP Working Group (WG) formed by the Commission in D.01-03-073 (Ordering Paragraph 16). The SGIP PAs have authorized Pacific Gas and Electric Company (PG&E) to make this filing on their behalf.

This motion requests that the due date for the SGIP Market Focused Process Evaluation Report be extended to **August 10, 2007**, from June 29, 2007 as set forth in the Administrative Law Judge's Ruling Granting Motion for Measurement and Evaluation Schedule Modification dated February 28, 2007. The SGIP PAs make this request as their independent third-party evaluators need additional time for analysis of interviews conducted for this evaluation report and the SGIP PAs believe that such analysis will result in a more useful report.
