ORDER

J. F. Douglas has filed an application with the Rail-
 road Commission in which he applies for a certificate of public
 convenience and necessity to operate automotive package service
 between Oroville and Swayne's Logging Camp, California.

Applicant at the present time is the possessor of an
 operative right secured through transfer under Decision No. 11898
 in Application No. 8840, dated April 5, 1923, which operative
 right authorizes the operation of automobile stage service for
 the transportation of passengers and freight between Oroville and
 Merrimac and intermediate points and for the transportation of
 passengers as an extension to said service between Merrimac and
 Swayne's Logging Camp. Under the existing application, applicant
 Douglas proposes to handle, in addition to passengers, small
 packages which can be carried in passenger automobiles at a charge
 of not to exceed twenty-five cents each.

In view of the fact that there is no existing service by
 public carrier for the transportation of packages to or from
 Swayne's Logging Camp as proposed by applicant herein, we are of

opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREBY DECLARES that public convenience and necessity require the operation by J. F. Douglas of an automotive stage line as a common carrier of packages, such packages to be limited in size as to be readily carried in a passenger automobile at a charge of not to exceed twenty-five (25) cents each between Oroville and Swayne's Logging Camp in connection with the existing passenger stage service of applicant between such points, and,

IT IS HEREBY ORDERED that a certificate of public convenience and necessity be and the same hereby is granted subject to the following conditions:

1. Applicant shall file his written acceptance of the certificate herein granted within a period of not to exceed ten (10) days from date hereof, which written acceptance to contain a statement to the effect that he fully understands that the certificate herein granted is not an additional operative right between Oroville and Swayne's Logging Camp, other than the additional right to carry packages as hereinabove specified on passenger automobile stages operated under the certificate obtained by him under Decision No. 11898; shall file, in duplicate, supplement to his existing tariffs on file with the Commission, covering the transportation of packages as herein authorized, such tariffs to be identical with the rates as set out in the application herein; and shall commence operation of the service herein authorized within a period of not to exceed thirty (30) days from date hereof.

2. The rights and privileges herein authorized may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.
