ORDER

M. J. Plasse has filed an application with the Railroad Commission in which he petitions for a certificate of public convenience and necessity authorizing the establishment of an automobile stage line as a common carrier of passengers and express between Jackson and Plasse's Resort and certain intermediate points, California.

This applicant at the present time operates a resort at Silver Lake and states in support of his application that there is at the present time no common carrier for the transportation of passengers and light express matter between Jackson, his resort, other resorts located at Silver Lake and certain intermediate points north of Volcano. There is at the present time an existing service between Jackson and Volcano, which will not be interfered with through the establishment of the present service as herein proposed.

One E. J. Keyes was heretofore granted a certificate of public convenience and necessity authorizing him to operate a similar service as that proposed by applicant. Due to financial

difficulties he failed to render any service whatsoever during the present season and the operative right heretofore granted him will be revoked concurrently with the granting of the present application.

Applicant herein proposes to use one 7-passenger Studebaker automobile and to operate two round trips per week during the summer season when the Silver Lake resorts are open for business; rates to be charged for passengers and express as set out in Exhibit "A" attached to the application.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREBY DECLARES that public convenience and necessity require the operation by M. J. Plasse of an automobile stage line as a common carrier of passengers and express during the summer season only between Jackson and Plasse's Resort serving as intermediate points Cook's Station, Ham's Station, Lumber Yard, Bear River Turn-Off, Corral Flat and Kay's Resort, and a certificate of public convenience and necessity be and the same hereby is granted, subject to the following conditions:

1. The right to transport express matter shall be limited to the transportation of packages, no single shipment of which shall exceed 100 pounds in weight.

2. Applicant shall file his written acceptance of the certificate herein granted within a period of not to exceed ten (10) days from date hereof; shall file, in duplicate, tariff of rates and time schedules within a period of not to exceed twenty (20) days from date hereof, such tariff of rates and time schedules to be identical with those filed as Exhibits "A" and "B" attached to the application herein; and shall commence operation of the service herein authorized within a period of not to exceed thirty (30) days from date hereof.

3. The rights and privileges herein authorized may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.

4. No vehicle may be operated by applicant herein unless such vehicle is owned by said applicant or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.
