ORDER

Southern Pacific Company, a corporation, having on September 19. 1923, filed with the Commission an application for permission to relocate its spur track at grade across Mission Road in the City of Alhambra County of Los Angeles, State of California as hereinafter indicated, and it appearing to the Commission that this is not a case in which a public hearing is necessary; that the necessary permit has been granted by the City Manager of said City of Alhambra for the relocation of said crossing at grade, and it further appearing that it is not reasonable nor practicable to avoid a grade crossing with said Mission Road, and that this application should be granted subject to the conditions hereinsfter specified,

IT IS HERRERY ORDERED, that permission be and it is hereby granted Southern Pacific Company to relocate its spur track at grade across Mission Road in the City of Alhambra. County of Los Angeles. State of California, to a location described as follows:

Beginning at a point in the northerly line of Mission Road; said point of beginning being distant 192 feet, more or less, measured westerly along said northerly line of Mission Road from its intersection with the westerly line of Marengo Avenue, thence southwesterly along a curve concave to the right, having a radius of 286.84 feet, a distance of 130 feet, more or less, to a point in the southerly line of Mission Road, said point being distant 286 feet more or less, measured westerly along said southerly line of Mission Road from its intersection with the westerly line of Marengo Avenue produced.

All of the above as shown by the map Los Angeles
Division Drawing F-7963, sheet 1 of 2 attached to the application;
said crossing to be relocated subject to the following conditions, viz:-

- (1) The entire expense of relocating the crossing, together with the cost of its maintenance thereafter in good and firstclass condition for the safe and convenient use of the public, shall
 be borne by applicant.
- (2) Said relocated crossing shall be constructed of a width and type of construction to conform to that portion of said Mission Road now graded, with the top of rails flush with the pavement, and with grades of approach not exceeding one (1) per cent; shall be protected by a suitable crossing sign, and shall in every way be made safe for the passage thereover of vehicles and other road traffic.
- (3) Applicant shall, within sixty (60) days of the date of this order, file a certified copy of a franchise from the Commission of the City of Alhambra granting authority to relocate said crossing across Mission Road.
- (4) Applicant shall, within thirty (30) days thereafter, notify this Commission, in writing, of the completion of the relocation of said crossing.
- (5) The authorization herein granted for the relocation of said crossing will lapse and become void one year from the date of this order unless further time is granted by subsequent order.

(6) The Commission reserves the right to make such further orders relative to the location, construction, operation, maintenance and protection of said crossing as to it may seem right and proper, and to revoke its permission if, in its judgment, the public convenience and necessity demand such action.

This order shall become effective three (3) days after the making thereof.
