This Commission, on January 9, 1923, having ordered (Decision 11484) Southern California Edison Company to reconstruct its overhead facilities to conform with the provisions of Chapter 499, Statutes of 1911 as amended by Chapter 600, Statutes of 1915, before December 31, 1923, and Southern California Edison Company having requested a further extension of time to reconstruct certain of its facilities mentioned in California Railroad Commission's Report of Infractions of Chapter 499-600 on the Southern California Edison Company's system, and good cause appearing.
