THIRD SUPPLEMENTAL ORDER

The Railroad Commission by Decision Number 12656, dated
September 24, 1923 and amended by Decision Number 13053, dated January 15, 1924, authorized Centerville Water Company to issue and sell
at not less than 95 percent. of their face value plus accrued interest \$25,000.00 of its ten year seven percent. first mortgage bonds
and to use approximately \$18,000.00 of the proceeds to pay indebtedness to F. E. McGurrin and approximately \$500.00 of the proceeds
to finance the cost of metering the company's water system. The
remainder of the proceeds may be expended only for such purposes as
the Commission might authorize in a supplemental order or orders.

In the supplemental petition filed in the above entitled matter on March 7, 1924, Centerville Water Company asks the Commission to modify its previous orders so as to permit it to use approximately \$2,102.02 of the proceeds from the sale of the \$25,000.00 of bonds to finance the cost of additions and betterments described in the supplemental petition, as follows:-

IT IS HEREBY ORDERED that the order in Decision Number 12656, dated September 24, 1923, as modified by Decision Number 13053, dated January 15, 1924, be, and it is hereby, further modified so as to permit Centerville Water Company to use approximately \$2,102.02 of the proceeds obtained from the sale of the \$25,000.00 of bonds authorised by said decisions for the purpose of financing the cost of the additions and betterments described in this order.

IT IS HEREBY FURTHER ORDERED that the order in Decision Number 12656, dated September 24, 1923, as modified by Decision Number 13053, dated January 15, 1924, shall remain in full force and effect except as modified by this Third Supplemental Order.
