NINETY-THIRD SUPPLEMENTAL ORDER

GREAT WESTERN POWER COMPANY

The Railroad Commission being by Section 8 of Chapter 499, Statutes of 1911 as amended by Chapter 600, Statutes of 1915, authorized to grant additional time during which overhead electric lines may be brought into compliance with the requirements of said Act and the Railroad Commission having found upon inspecting the overhead electric lines of Great Western Power Company in its San Francisco, Northwestern and Sacramento Divisions (See Decisions #12665 and #13137 for Oakland Division) certain infractions of said Act and Great Western Power Company having requested an extension of time to bring its overhead electric facilities into compliance with the provisions of said Act, and good cause appearing,

IT IS HEREBY ORDERED, that the time during which Great Western Power Company may reconstruct its overhead electric lines in its San Francisco (exclusive of the area formerly served by the


Universal Electric and Gas Company) Northwestern, Big Bend, Big Meadows and Sacramento Divisions to conform to the provisions of Chapter 499, Statutes of 1911 as amended by Chapter 600, Statutes of 1915, be and the same is hereby extended as follows:

San Francisco Division	extended to July 1, 1924
Northwestern Division	extended to July 1, 1924
Big Bend Division	extended to October 1, 1924
Big Meadows Division	extended to October 1, 1924
Sacramento Division	extended to January 1, 1925

provided that as to certain infractions listed as "Technical, prior to October 22, 1911" upon copies of field reports of the inspection which have been furnished Great Western Power Company or its agents by this Commission, such time is hereby extended until such infractions can be eliminated in the course of maintenance or construction work.

IT IS HEREBY FURTHER ORDERED, that Great Western Power Company complete in the Divisions and within the time as above set forth, the construction of its overhead electric lines to eliminate all infractions of Chapter 499, Statutes of 1911 as amended by Chapter 600, Statutes of 1915, listed as "Hazardous or technical since October 22, 1911" upon copies of field reports heretofore referred to and all hazardous conditions similarly listed.
