FIFTH SUPPLEMENTAL ORDER

The Railroad Commission by Decision Number 12931, dated December 14, 1923, suthorized the Oakland and Haywards Railway Company to issue \$236,000.00 of 15-year first mortgage six percent.bonds subject, among others, to the condition that none of the bonds be issued until the Commission by a supplemental order has authorized the company to execute a mortgage or deed of trust to secure the payment of such bonds. On May 14th there was filed in the above entitled matter a supplemental petition in which the Commission is asked to make an order authorizing the Cakland and Haywards Railway Company to execute a mortgage or deed of trust substantially in the same form as that filed on said date with the Commission. The proposed mortgage or deed of trust has been considered by the Commission. The same is in satisfactory form.

IT IS HEREBY OFDERED that the Oakland and Haywards Railway Company be, and it is hereby, authorized to execute a mortgage or deed of trust substantially in the same form as the mortgage or deed of trust filed with this Commission on May 14, 1924, for the purpose of securing the payment of \$236,000.00 first mortgage six percent. bonds due July 1, 1938, provided that the authority herein granted to execute a mortgage or deed of trust is for the purpose of this proceeding only and is granted in so far as this Commission has jurisdiction under the terms of the Public Utilities Aut, and is not intended as an approval of such mortgage or deed of trust as to such other legal requirements to which said mortgage or deed of trust may be subject; provided further, that Oakland and Haywards Railway Company shall file with the Commission a certified copy of said mortgage or deed of trust as soon as said mortgage or deed of trust is executed.

IT IS HEREBY FURTHER ORDERED that the Order in Decision Num- . ber 12931, dated December 14, 1923, as amended, shall remain in full force and offect, except as modified by this Fifth Supplemental Order.
