## ORDER

In the above entitled application the Southern Pacific Railroad Company and Southern Pacific Company, seek authority to make an exchange of right-of-way, sale of tracks, and construction of drill track, in the vicinity of Clement Junction, east of Alameda Street and south of East 25th Street, in the City of Vernon, County of Los Angeles, State of California, the physical features of which are delineated upon Los Angeles Division Drawing F-8952, Sheet 1 of 1, Form 30 L.A., attached to said application, the applicants proposing more particularly,

1. To sell and convey to Consumers Rock and Gravel Company the spur track right-of-way 2075 feet, more or less, in length, tinted yellow upon said blue print map;

2. To accept in exchange a right-of-way of approximately equal length marked "Parcel A", tinted red, upon said blue print maps

3. To accept reservation, for spur and industrial tracks, of the fifteen foot strip of land marked "Parcel No. 1", lying northerly of and adjacent to above mentioned right-of-way marked "Parcel A";

4. To sell and convey for the sum of \$11,620.00, present market value, to Consumers Rock and Gravel Company, the existing industrial tracks shown by solid mauve lines upon said blue print map;

5. To construct a drill track upon right-of-way marked "Parcel A".

It appears that the parties in interest are agreed upon all terms and conditions, that the proposed exchange and sale of rights-of-way and tracks are equitable and not opposed to the public interest, and that this proceeding is one for which a public hearing is not necessary; therefore

IT IS HEREBY ORDERED that permission and authority be and it is hereby granted Southern Pacific Railroad Company and Southern Pacific Company to effect the exchange of the rights-of-way sale of existing industrial tracks, construction of drill track, and acceptance of reservation of land for industrial tracks, all as proposed and upon terms and conditions outlined in the application and delineated upon the blue print map hereinbefore described.

This order shall take effect immediately.
