BY THE COMMISSION:

OBINION

C. H. Warrington has made application to the Hailroad Commission for a certificate of public convenience and necessity to operate live stock track transportation service between Los Angeles Union Stock Yards, Globe Mills Feed Yard, Vernon Packing House District, and packing houses in the City of Los Angeles and at Signal Hill in the county of Los Angeles.

A public hearing herein was conducted by Examiner Williams at Los Angeles.

Applicant proposes the transportation of live stock between the Los Angeles Union Stock Yards and various points by specially constructed vehicles for this purpose and at rates based upon the capacity load of the vehicles and trailers. This service has been performed by applicant for a considerable period without a certificate and in ignorance that a certificate

was necessary. When the nature and limitation of the transportation service offered was explained, opposition was withdrawn by all protestants as the business is of a character which none of the protestants or other carriers is equipped to perform or wish to perform. Applicant was supported in his request for a certificate by the California Dressed Beef Company. Los Angeles Packing Company, Woodward-Bermett Company, Merchants' Packing Company, Globe Packing Company, Coast Packing Company, and Southern California Meat Company, who joined in a petition in his behalf reciting that under the rulings of the Live-stock Inspection Bureau, animals must be killed within forty-eight hours after arrival in Los Angeles and stating that the switching from point to point of cars containing a small number of animals was impracticable and too dilatory to meet this requirement and that the service performed by applicant was of walne to theme

In view of the facts before us in this matter, we find that public necessity and convenience require the service proposed by applicant and that a certificate should be issued therefor.

<u>o r d e r</u>

C. H. Warrington, having made application to the Railroad Commission for a certificate of public convenience and necessity to operate live stock transportation service between Los Angeles Union Stock Yards, Globe Mills Feed Yard, Vernon Packing House District, and packing houses in the City of Los Angeles and at Signal Hill, County of Los Angeles, a public hearing having been held, the matter having been duly submitted and now being held

for decision,

THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREEY DECLARES that public convenience and necessity require the establishment of the operation proposed by applicant herein over and along the following routes:-

> Routes to and from Globe Mills Feed Yards and Union Stock Tards.

- 1. Signal Hill:- Via Downey Road to Downey, thence south Via College St. Ocean Ave., and Cherry St. to Signal Hill Packing Co.
- 2. Los Angeles:- Via Downey Road and East 9th St. to Houser Packing Co.
- 3. Los Angeles:- Via Downey Road, East 9th St. Santa Fe Ave., and Lyon St., to Wilson and Cudaby Packing Houses.
- 4. Los Angeles:- Via Downey Road, East 9th St. Boyle Ave., Chicago St. East 1st St., Pleasant St., Summit Ave., Aliso St., and Lyon St. to Wilson Packing House, or Via Macy St., to Cudaby Packing House.
- 5. Vernon: Via Downey Road, and Vernon Ave., to Vernon Packing House District.

and that a certificate of public convenience and necessity therefor be and the same hereby is granted subject to the following conditions:-

- I. That applicant, C. H. Warrington shall file within fifteen (15) days from date hereof his written acceptance of the certificate herein granted, and shall file within thirty (30) days of the date hereof, duplicate tariff of rates and time schedules, in accordance with General Order No. 51 of the Railroad Commission, and shall begin service within sixty (60) days from date hereof.
- II. That applicant, C.H.Warrington shall not sell, lease assign or discontinue the service herein authorized, unless such sale, lease, assignment, or discontinuance shall have been authorized by the Railroad Commission.

III. - That no vehicle shall be operated by applicant unless such vehicles are owned by said applicant, or are leased under an agreement satisfactory to the Railroad Commission.
