ORDER


THE MOUNTAIN COPPER COMPANY, LIMITED, having, on July 7, 1924, been granted, for a term of twenty years by the Board of Trustees of the City of Martinez, the right, privilege and franchise to improve, maintain and operate a wharf on the following described location in the City of Martinez, County of Contra Costa, State of California, to-wit:


Beginning at a point on the southern shore of Suisun Bay on the northern boundary line of the Rancho Las Juntas, said point being at the north-west corner of the tract of land purchased by The Mountain Copper Co., Limited, from the Bull's Head Oil Works by deed dated July 12th, 1904, and recorded in the County Recorder's office of Contra Costa County, in Vol. 105 Deeds, page 577; thence north 20° west, true meridian, 1160 feet to station on the line of Ship's Channel in Suisun Bay; thence north 73° east along the line of Ship's Channel 670 feet to station, 150 feet distant at right angles from a continuation of the western line of the wharf franchise of Peyton Chemical Company; thence south 34° east parallel to the western boundary line of the wharf franchise of the Peyton Chemical Company and 150 feet distant therefrom, 2070 feet to station; thence south 43-3/4° west 500 feet to the station at the northern end of Course No. 16 of the Official Survey of the Rancho Las Juntas; thence following the northern boundary line of the Rancho Las Juntas in a northwesterly and southwesterly direction into the point of beginning.


and having applied to the Railroad Commission for approval of said right, privilege and franchise, and having submitted to the Railroad Commission copies of its Articles of Incorporation and of its application to the Board of Trustees of the City of Martinez, together with a copy of the order of said Board of Trustees granting said right, privilege and franchise; and the Commission being of the opinion that this is not a case in which a public hearing is necessary and that this application should be granted;

NOW, THEREFORE, IT IS HEREBY ORDERED that the Railroad Commission hereby approves the right, privilege and franchise described in the application herein; provided, that this order will not become effective until the Mountain Copper Company, Limited, has filed with the Railroad Commission, for approval, a stipulation, duly authorized by its Board of Directors, declaring that neither the Mountain Copper Company, Limited, nor its successors or assigns, will ever claim before the Railroad Commission, or any court or other public body, a value for said right, privilege and franchise in excess of the amount actually paid to the City of Martinez as a consideration for the granting of said right, privilege and franchise, which amount shall be stated in the stipulation, and shall have received from the Railroad Commission a supplemental order declaring that such stipulation has been filed in form satisfactory to said Railroad Commission.
