ORDER

In this proceeding H. B. Webster and Nelson L. Hawks, partners, ask the Commission to approve the transfer by them to P. E. Tibbetts of a certificate permitting the operation of an auto service for the transportation of freight between Los Angeles on the one hand and Los Alamitos, Westminster, Wintersberg, Huntington Beach, Newport and Balboa Beach.

The certificate was originally granted to a partnership consisting of H. B. Webster, E.C. Twitchell and Edwin B. Palmer, who were given authority to operate in Decision No. 12803 on Application No. 9373. Subsequently, in Decision No. 13007, on Application No. 9653, the operating right was transferred to Webster and Hawks, a new partnership.

The consideration to be paid for the property herein proposed to be transferred is the sum of \$8000.00, of which amount \$6500 represents the value of truck and office equipment, \$1000.00 the value of a depot lease extending over a period of 7 years and \$500.00 the value of the good will of the business.

We believe that this application should be granted and that it is not a matter requiring a public hearing.

IT IS HEREBY ORDERED that the above entitled application be, and the same hereby is granted, subject to the following conditions:

1. The consideration to be paid for the property herein authorized transferred may not be urged before this Commission or any other rate fixing body as a measure of value of said property for rate fixing or any purpose other than the transfer herein authorized.

2. Applicants Webster and Hawks, partners, shall immediately cancel tariff of rates and time schedules on file with the Commission covering service, certificate for which is herein authorized transferred. Such cancellation to be in accordance with the provisions of General Order No. 51.

3. Applicant Tibbetts shall immediately file, in duplicate, or adopt as his own the tariff of rates and time schedules heretofore filed by the co-partners covering said service. All filings by applicant Tibbetts to be identical with those as filed by the co-partners.

4. The rights and privileges herein authorized transferred may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission thereto has first been obtained.

5. No vehicle may be operated by applicant

Tibbetts unless such vehicle is owned by him  
or is leased under a contract or agreement on  
a basis satisfactory to the Railroad Commission.
