O R D E R

Inglewood Water Company, a corporation, engaged in the public utility business of supplying water for domestic and irrigation purposes in the territory surrounding the incorporated City of Inglewood, having made application to this Commission for authority to transfer for the sum of forty-five hundred ninety-five and 50/100 dollars (\$4,595.50) its cast iron distribution pipe system, together with certain service connections and meters thereto attached, as more particularly described in the application herein, to the Board of Public Service Commissioners of the City of Los Angeles, a municipal corporation, which joins in the application, and it appearing that this is not a matter in which a public hearing is necessary and that the application should be granted,

IT IS HEREBY ORDERED that Inglewood Water Company, a corporation, be and it is hereby authorized to transfer to the Board of Public Service Commissioners of the City of Los Angeles,

a municipal corporation, the cast iron distribution pipe system together with certain service connections and meters attached thereto, more particularly described in the application herein and in accordance with the terms and conditions as set out in said application.

IT IS HEREBY FURTHER ORDERED that the authority herein granted shall be subject to the following conditions:

1. The authority herein granted shall apply only to such transfer as shall have been made on or before June 30, 1925, and a certified copy of the instrument of conveyance shall be filed with this Commission by said Inglewood Water Company within thirty (30) days from the date on which it is executed.
2. Within ten (10) days from the date on which Inglewood Water Company actually relinquishes control and possession of the properties herein authorized to be sold, said Inglewood Water Company shall file with this Commission a certified statement indicating the date upon which such control and possession was relinquished.

IT IS HEREBY FURTHER ORDERED that upon full compliance with the terms and conditions of the order herein, Inglewood Water Company, a corporation, shall be relieved of its public utility obligations to render water service to consumers heretofore served by it through the distribution system herein authorized to be transferred.

The authority herein granted shall become effective on the date hereof.
