Puente City Water Company, a corporation, which owns and operates a public utility serving water to consumers who reside in and in the vicinity of Puente, Los Angeles County, has made application to this Commission for suthority to transfer the system to the La Puente Valley County Water District, which joins in the application.

A public hearing in this proceeding was held before Examiner Williams at Los Angeles, after all interested parties had been duly notified and given an opportunity to be present and be heard.

The evidence shows that the La Puente Valley County Water District is duly organized under that certain act known as "County Water District Act No. 1, Act No. 5506 of 1923" of the General Laws of the State of California; also that it has entered into an agreement with the Puente City Water Company to purchase all land, personal property, right-of-way easements, or other covenants which are a part of, or belong to, the Puente

City Water Company.

The evidence also shows that the La Puente Valley County Water District has voted \$135,000 in bonds for the purpose of providing a water system, of which \$35,000 will be used in acquiring the property of the Puente City Water Company. It was also shown that all the territory now obligated to be served with water by Puento City Water Company is included in the La Puento Valley County Water District except seventeen acres of walnut land which the District has agreed to serve as land outside its territory. The District also proposes to develop additional water supply which will insure the consumers a better service.

No one appeared to protest the granting of this application, and it is apparent that the interests of the consumers will be served best by the authorization of the transfer.

Puente City Water Company, a corporation, having made application to this Commission for authority to transfer its public utility water system to the La Puente Valley County Water District, which joins in the application, a public hearing having been held thereon, the matter having been submitted and the Commission being now fully informed thereon,

IT IS HEREBY ORDERED that Puente City Water Company, a corporation, be and it is hereby authorized to transfer to the La Puente Valley County Water District all land, personal property, right-of-way easements, or other covenants which are a part of or belong to the Puente City Water Company, and more particularly described in Exhibit "A" attached hereto, and in accordance with the terms and conditions as set out in the application.

IT IS HEREBY FURTHER ORDERED that the authority herein granted shall be subject to the following conditions:

- 1. The authority herein granted shall apply only to such transfer as shall have been made on or before September 1st, 1925, and a certified copy of the instrument of conveyance shall be filed with this Commission by said Puente City Water Company within thirty (30) days from the date on which it is executed.
- 2. Within ten (10) days from the date on which Puente City Water Company actually relinquishes control and possession of the property herein authorized to be sold, it shall file with this Commission a certified statement indicating the date upon which such control and possession was relinquished.
- 3. The consideration given for the transfer of this property shall not be urged before this Commission or any other public body as a finding of value of the property for rate fixing or for any purpose other than the transfer herein authorized.

For all other purposes, the effective date of this order shall be twenty (20) days from and after the date hereof. Dated at San Francisco, California, this <u>30</u> day of July, 1925.

DESCRIPTION OF THE REAL PROPERTY TO BE CONVEYED BY THE PUENTE WATER COMPANY, A CORPORATION, TO THE LA PUENTE VALLEY COUNTY WATER DISTRICT
