BY THE COMMISSION -

<u>CPINION and ORDER</u>

In this proceeding the Railroad Commission is asked to make an order authorizing :

1- The transfer of the operative rights of Pickwick Stages, Inc. to Pickwick Stages System.

2- The issuance by Pickwick Stages System to Pickwick Stages, Inc. of One Eundred Eighty Thousand Three Hundred Dollars (\$180,300) par value of the common capital stock of Pickwick Stages System.

3- The transfer of the franchises and operating rights of Murrietta Mineral Hot Springs Auto Stage Line to Pickwick Stages System.

4- The issuance by Pickwick Stages System to Murrietta Mineral Hot Springs Auto Stage Line of Twenty-four Thousand One Hundred Dollars (\$24,100) par value of the common capital stock of Pickwick Stages System.

5- The consolidation of the operative rights transferred from Murrietta Mineral Hot Springs Auto Stage Line and Pickwick Stages, Inc. 6- The sale and issuance by Pickwick Stages System of One Hundred Thousand Dollars (\$100,000) par value of its common capital stock without any allowance for brokerage or commission, the proceeds thereof to be used in the reduction of its liabilities represented by capital assets.

A public hearing was held before Examiner Handford at San Francisco, the matter was duly submitted and it is now ready for decision. The granting of the application was not protested.

Each of the applicants in the above entitled proceeding is a corporation engaged in the business of transporting persons and property over the highways of California under authority of certificate of public convenience and necessity issued at various times by the Railroad Commission. As integral parts of the Pickwick Stages System their operations have been conducted under one management. The instant proceeding is based principally on the claim that economy in the operation of the business of the corporations involved will result if the application be granted, with particular reference to the handling of ticket sales, accounting and inter-leasing of equipment. This, in effect, was the testimony of the only witness testifying at the hearing.

The operating rights of Murrietta Mineral Hot Springs Auto Stage Line and those of Pickwick Stages, Inc., parallel each other between the cities of Anaheim and Los Angeles and also between Murrietta Mineral Hot Springs and Elsinore. Consolidation of these rights, as proposed, and their transfer to Pickwick Stages System will make it possible for the Pickwick System to handlo passengers from the Hot Springs, Murrietta and Elsinore and intermediate points to and from Los Angeles either by way of Corona or by way of Riverside, the alternate routing making for a lessening of the use of overload equipment with a consequent reduction in cost of operation and a better public service.

The operating rights herein sought to be transferred were granted by the Railroad Commission in accordance with the follow-

Decision No.8794, dated April 27, 1923, issued on Application No.8794 - Between San Diego and Escondido and intermediate points.

Decision No.9588, dated October 4, 1921, issued on Application No.7138 - Between Los Angeles and Murrietta Mineral Ect Springs and between Murrietta Mineral Hot Springs and Warner's Hot Springs.

Transfer of the above listed operating rights and their consolidation as petitioned for will be authorized in the order herein. Pickwick Stages System asks permission to issue at par \$304,400 of stock for the following purposes:

- \$180,300 to acquire the equity in the properties of Pickwick Stages, Inc.
 - 24,100 to acquire the equity in properties of Murrietta Mineral Hot Springs Auto Stage Line, and

100,000 to pay indebtedness.

The Pickwick Stages System proposes to acquire all of the properties of the Pickwick Stages Inc. and Murrietta Mineral Hot Springs Auto Stage Line and in payment for such properties assume the indebtedness of the two companies and issue stock, as above indicated.

The assets and liabilities of the Pickwick Stages, Inc. as of June 30, 1925, are reported as follows:

The Pickwick Stages System intends to assume the payment of the liabilities of Pickwick Stages, Inc. and issue to that company in payment for its properties \$180,300 of stock and pay \$47.75 in cash.

At the hearing had, Warren E. Libby, Secretary of Pickwick Stages, Inc. testified that the \$44,894.81 now charged to franchises should be increased by \$4,581.00 which is said to represent legal expenses incurred in connection with the acquisition of operative rights and defending the company's operative rights against com petition or adjudicating such operative rights. It appears that all of the \$4,581. except \$75. represents expenditures incurred to defend the operative rights of Pickwick Stages, Inc. or prevent competition, or prosecute applications for new operative rights, which applications remain undecided. Mr. Libby expressed the opinion, that legal expenses incurred for the purpose of protecting the company's existing operative rights were proper charges to capital account. We are unable to agree with him in this respect and are of the opinion that of the \$4,581. only \$75. can be included under charges to capital account. The \$44,894.81 includes \$6,500. which the Commission has heretofore (Decision No.9612 dated Oct. 14, 1921, Vol.20 Opinions and Orders of the Railroad Commission of California, page 672), recognized as proper charges to capital account. Deducting the \$6500 from the \$44,894.81, leaves \$38,394.81. There is nothing in the record to show the cost to the original grantees of franchises of the Pickwick Stages, Inc. carried on that company's books at \$38,394.81. Of the charges made, to intangible capital account (franchises) we can on the basis of the record recognize only \$6,575. as a proper charge to that account for the purpose of issuing stock. Making the necessary adjustment in the company's total accounts, we find that the Pickwick Stages System should be permitted to issue \$142,000. of stock to adquire the equity in the properties of the Pickwick Stages, Inc.

Referring to the Murrietta Mineral Hot Springs Auto Stage Line, the applicants report assets as follows:

Against these properties the Pickwick Stages System asks permission to issue stock in the amount of \$24,100., pay cash \$69.90 and assume the payment of \$923.06 in liabilities. It will be noted that the assets include an item of \$5000. charged to franchises. There is nothing in the record which enables the Commission to determine whether this represents the cost of franchises to the original grantee or to subsequent owners. The testimony does not justify the Commission to include the \$5000. in the assets of Murrietta Mineral Hot Springs Auto Stage Line for the purpose of authorizing the issue of stock. The order will authorize the issue of \$19,000. of stock to acquire the equity in the properties of the Murrietta Line.

Pickwick Stages System asks permission to issue and sell at par \$100,000 of stock and use the proceeds to pay indebtedness which it intends to assume or pay indebtedness which it incurred in connection with the acquisition of new stage equipment. The issue of this stock will be authorized by the order herein.

ORDER

Pickwick Stages System, having applied to the Railroad Commission for permission to issue \$304,400. of stock for the purposes indicated in the foregoing opinion, a public hearing having been held before Examiner Handford and the Railroad Commission being of the opinion that the money, property or labor to be procured or acquired by the issue of \$261,100. of stock is

reasonably required by Pickwick Stages System and that the application insofar as it relates to the issue of \$43,300 of stock, should be denied without prejudice;

IT IS MERENY ORDERED that for the purpose of acquiring the assets of Pickwick Stages, Inc., as of June 30, 1925, Pickwick Stages System be, and it hereby is, authorized to issue \$142,000 of stock, and to assume the payment of indebtedness of said corporation.

IT IS HEREBY FURTHER ORDERED that, for the purpose of acquiring the assets of Marrietta Mineral Hot Springs Auto Stage Line as of June 30, 1925, Pickwick Stages System be, and it is hereby, authorized to issue \$19,100 of stock and assume the payment of the liabilities of said company.

IT IS HEREBY FURTHER ORDERED that Pickwick Stages System be, and it hereby is, authorized to issue and sell at par \$100,000 of its common capital stock and use the proceeds to pay indebtedness assumed in connection with the purchase of the properties by Pickwick Stages, Inc. and of Murrietta Mineral Hot Springs Auto Stage Line, or to pay indebtedness which it incurred in connection with the acquisition of additional auto stage equipment and referred to in its balance sheet as of June 30, 1925.

IT IS HEREBY FURTHER ORDERED that Pickwick Stages System shall keep such record of the issue, sale and delivery of the stock herein authorized and of the disposition of the proceeds as will enable it to file on or before the 25th day of each month a verified report, as required by the Railroad Commission's General Order No.24, which order insofar as applicable, is made a part of this order.

IT IS HEREBY FURTHER ORDERED that the authority herein granted to issue stock and to assume the payment of indebtedness and acquire properties. Shall become effective when Pickwick Stages System has paid the fee prescribed by Section 57 of the Public Utilities Act, which fee is \$41.

IT IS HEREBY FURTHER ORDERED that the operating rights heretofore granted to Pickwick Stages, Inc., which rights are more specifically described in the opinion preceding this order be, and the same hereby are authorized to be transferred to Pickwick Stages System, a corporation.

IT IS HEREBY FURTHER ORDERED that the operating right heretofore granted to Murrietta Mineral Hot Springs Auto Stage Line, a corporation, which right is more specifically described in the opinion preceding this order, be and the same hereby is authorized to be transferred to Pickwick Stages Sytem, a corporation,

IT IS HEREBY FURTHER ORDERED that the operating right heretofore granted to Marrietta Mineral Hot Springs Auto Stage Line, a corporation, be and the same hereby is authorized to be consolidated with the operating rights heretofore granted to Pickwick Stages, Inc., all of the rights herein authorized to be consolidated, being more specifically described in the opinion preceding this order.

IT IS HEREBY FURTHER ORDERED that Pickwick Stages, Inc., and Murrietta Mineral Hot Springs Auto Stage Line, a corporation, shall immediately cancel the tariffs of rates and time schedules filed in their respective names with the Railroad Commission, and Pickwick Stages System, a corporation, shall immediately issue in its own name a tariff of rates and time schedules which shall be identical with the rates and time schedules of Pickwick Stages, Inc., and Murrietta Mineral Hot Springs Auto Stage Line, except as

to the time schedules affected by the consolidation herein RAILROND COMMUNICATION and no change shall be made in said time schedules Contraction in the schedules is first obtained from the Railroad DEC 281925
