CPINION and ORDER

Amy Goodwin Harvey, as Administratrix of the estate of James A. Harvey, also known as J. A. Harvey, has petitioned the Railroad Commission for an order approving the transfer of an operating right for an automobile service for the transportation of passengers and freight between Santa Cruz and Boulder Creek and intermediate points to Amy Goodwin Harvey, distributee of the estate of James A. Harvey, also known as J. A. Harvey, and Amy Goodwin Harvey asks for authority to acquire said operating right and to hereafter operate thereunder.

Attached to the application herein and made a part thereof is a copy of a decree of final distribution of the Superior Court of the County of Santa Cruz, distributing to said Amy Goodwin Harvey the estate of said James A. Harvey, also known as J. A. Harvey, said distribution insofar as it refers to the operating right for the Boulder Creek Stage Lines being subject to the approval of the Railroad Commission.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

conditions:

- 1- The consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission or any other rate fixing body as a measure of value of said property for rate fixing, or any purpose other than the transfer herein authorized.
- 2- Applicant Amy Goodwin Harvey. as Administratrix of the estate of James A. Harvey, also known as J. A. Harvey, shall immediately withdraw tariff of rates and time schedules on file with the Commission covering service, certificate for which is herein authorized to be transferred. Such withdrawal to be in accordance with the provisions of General Order No.51.
- 3- Applicant Amy Goodwin Harvey shall immediately file in her own name. in duplicate, tariff of rates and time schedules which rates and time schedules shall be identical with those on file with the Railroad Commission in the name of James A. Harvey.
- 4- The rights and privileges herein authorized may not be sold, leased, transferred nor assigned, nor service thereunder discontinued, unless the written consent of the Bailroad Commission to such sale, lease, transfer, assignment or discontinuance has first been secured.
- 5- No vehicle may be operated by applicant Amy Goodwin Harvey unless such vehicle is owned by said applicant or is leased under a contract or agreement on a basis satisfactory to the Railroad Commission.
