John Hamo and A. Semonian, co-partners, have petitioned the Railroad Commission for an order approving the sale and transfer of an operating right for an auto truck service for the transportation of milk and other dairy products and dairy feed and sup plies to Isaac Sahkarian, Tom Kardasian and Joe Puremian, co-partners, and Sahkarian, Kardasian and Puremian, co-partners, have applied for authority to purchase and acquire said operating right and to hereafter operate thereunder, the sale and transfer to be in accordance with an agreement of sale marked Exhibit A. which exhibit is attached to the application herein and made a part thereof.

The consideration to be paid for the property herein proposed to be transferred is given as \$8180, of which amount \$7180 is said to represent the value of certain equipment and \$1000 is named as the value of the operating right.

The operating right herein sought to be transferred was granted to Hamo and Semonian by the Railroad Commission in its Decision No.15528, dated October 15,1925, and Decision No.15805 dated December 28, 1925, Decision No.15805 amending the route as set forth in Decision No.15528.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted. IT IS HEREBY ORDERED that the above entitled application be and

the same hereby is granted, subject to the following conditions:

1- The consideration to be paid for the property herein suthorized to be transferred shall never be urged before this Commission or any other rate fixing body as a measure of value of said property for rate fixing, or any purpose other than the transfer herein authorized.

2- Applicants Hamo and Semonian shall immediately withdraw tariff of rates and time schedules on file with the Commission covering service, certificate for which is herein authorized to be transferred. Such withdrawal to be in accordance with the provisions of General Order No.51.

3- Applicants Schkarian, Kardssian and Peremian shall immediately file, in duplicate, tariffs of rates and time schedules or adopt as their own the tariff of rates and time schedules for said service as heretofore filed by applicants.Hamo and Semonian. All tariff of rates and time schedules to be identical with those as filed by applicants Hamo and Semonian.

4- The rights and privileges herein authorized may not be sold, leased, transferred nor assigned, nor service thereunder discontinued, unless the written consent of the Railroad Commission to such sale, lease, transfor, assignment or discontinuance has first been secured.

5- No vehicle may be operated by applicants Sahkarian, Kardasian and Puremian unless such vehicle is owned by said applicants or is leased under a contract or agreement on a basis satisfactory to the Railroad Commission.
