## OPINION ON REHEARING

On May 14, 1925, this Commission rondered its Decision No. 14922 on the above entitled application establishing therein a revised and increased schedule of water rates to be charged consumers of the public utility water system owned and operated by irthur W. Nicholls at Dutch Flat, California.

Thereafter the applicant, Arthur W. Micholls, filled a petition for a rehearing of this proceeding, requesting the Commission to issue a further order granting certain minor modifications and changes in the rate schedule established in Decision To. 14922, to fix a more equitable distribution of the charges, principally for the use of water for irrigation of gardens and to yield a small amount of additional revenue which he contended necessary in order to return approximately the annual charges allowed by the Commission in its decision.

This rehearing was granted, and after due notice thereof given to all interested parties a public hearing was held at Dutch

Flat on Soptember 29, 1925, bofore Examiner Satterwhite.

Applicant introduced additional data regarding water use on the system showing the amount and character of garden irrigation use and also setting forth the probable annual revenue which would be realized under the rates as fixed in said Decision No. 14922.

From an analysis of the above data and after a review of the evidence previously submitted in this proceeding, it appears that certain adjustments and modifications of the schedule of rates as heretofore established reasonably and properly should be made. These changes will result in more equitable irrigation charges but will not materially increase the charges to the individual consumers. Accordingly the schedule of rates as set out in the accompanying order has been designed to return approximately the annual charges of the system which the Commission had found to be reasonable and necessary.

## ORDER ON REHEARING

irthur W. Micholls having made application for a rehearing of the above entitled proceeding, such rehearing having been
granted, a public hearing having been held thereon, the matter having been submitted and the Commission now being fully informed in
the premises.

IT IS HERREY ORDERED that the order of this Commission in its Decision No. 14922, dated May 14, 1925, rendered in the above entitled proceeding be and the same is hereby modified in the following particulars:

IT IS HEREBY ORDERED that Arthur W. Nicholls be and he is hereby authorized and directed to file with the Railroad Commission within twenty (20) days from the date of this order the following schedule of rates to be charged for all water delivered

to his consumers in Dutch Flat and vicinity, in Placer County, on and after the first day of March, 1926:
