TENTH SUPPLEMENTAL ORDER

In a petition filed on April 1, 1926, Sonoma Valley Water
Light and Power Company and Sonoma Water and Irrigation Company
asked the Commission to vacate and set aside Decision No. 10089
dated February 15, 1922 in the above entitled proceeding and restore
to effect Decision No. 9683 dated October 31, 1921.

By said Decision No. 10089 the Commission modified Con-
dition No. 2 of the order in said decision No. 9683 so as to read:-

"The common stock herein authorized to be issued shall be
delivered to the Sonoma Valley Water, Light and Power Company
in part payment for its properties more fully described in
Schedule "I" attached to Decision No. 9683, dated October 31,
1921, which properties the Sonoma Water and Irrigation Company
is hereby authorized to purchase, subject to an indebtedness
of not exceeding \$10,000.00."

Condition No. 2 of the order in said Decision No. 9683 prior to its modification by said Decision No. 10089 read as follows:-

" The common stock herein authorized to be issued, together with \$10,000. obtained from the sale of preferred stock, when the expenditure of said \$10,000. is hereafter authorized by the Commission, shall be delivered to the Sonoma Valley Water Light and Power Company in full payment, free and clear of all encumbrances, for its properties more fully described in Schedule "1" attached hereto."

The Sonoma Water and Irrigation Company, according to reports filed with the Commission, issued as part payment for the properties of the Sonoma Valley Water Light and Power Company the \$40,000.00 of common stock authorized by said Decision No. 9683.

The Commission has authorized Sonoma Water and Irrigation Company to use \$3,741.90 obtained from the sale of its preferred stock to pay debts incurred by Sonoma Valley Water Light and Power Company. Applicants are of the opinion that it is to their advantage to have Decision No. 10089 vacated and set aside, and further, to have applicants restored to the rights, privileges and powers, as defined in said Decision No. 9683, due credit being allowed to the Sonoma Water and Irrigation Company for the sum of \$3,741.90 heretofore paid. After deducting the \$3,741.90 from the \$10,000. referred to herein, there remains a balance of \$6,258.10. The Sonoma Water and Irrigation Company asks permission to deliver \$6,258.10 obtained from the sale of its preferred stock to the Sonoma Valley Water Light and Power Company, as further and final payment for the properties acquired from it.

The Commission has considered the requests of applicants and is of the opinion that such requests should be granted, therefore, IT IS HEREBY ORDERED as follows:-

1. Decision No. 10089 dated Feb. 15, 1922, be, and it is hereby vacated and set aside.
2. Condition No. 2 of the order in said Decision No. 9683 is hereby revived and applicants restored to the rights, privileges and powers, as defined in said

decision No. 9683, provided due credit is allowed to the Sonoma Water and Irrigation Company for the sum of \$3,741.90 heretofore paid on account of debts incurred by the Sonoma Valley Water Light and Power Company.

3. Sonoma Water and Irrigation Company is hereby authorized to use \$6,258.10 obtained from the sale of its preferred stock to pay in part, and make the final payment, of the purchase price of the properties of Sonoma Valley Water Light and Power Company, said \$6,258.10 being in addition to the \$3,741.90 heretofore authorized to be used by said Sonoma Water and Irrigation Company to pay debts incurred by the Sonoma Water Light and Power Company.

4. The order in Decision No. 9683 dated October 31, 1921, as amended, shall remain in full force and effect, except as modified by this Tenth Supplemental Order.
