OPINION and ORDER

Enrico N. Cunco has petitioned the Emilroad Commission for an order declaring that public convenience and necessity require the operation of an automobile service for the transportation of passengers, baggage and packages between Jackson and Cook's Station and intermediate points.

Applicant proposes to give service and to charge rates and fares as set forth in Exhibits "A" and "B", which exhibits are attached to the application herein and made a part thereof. The equipment proposed to be used is shown in Exhibit "C" which is also attached to the application herein and made a part thereof.

In support of his claim that public convenience and necessity require the service herein proposed, applicant Sumeo alleges that the territory through which it is proposed to give service is to be the scene of hydro-electric development and construction work which will give employment to hundreds of men, all of whom will require transportation facilities for themselves and their baggage. It is further alleged that the recent development of Cook's station as a summer resort has also

created a domand for transportation facilities.

Applicant Cuneo is already operating an automobile service over part of the route between Jackson and Cook's Station. Under authority of the Railroad Commission he is transporting passengers and freight between Jackson and Volcano via Pine Grove. The road to Cook's station branches off at Pine Grove.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

The Railroad Commission of the State of California hereby declares that public convenience and necessity require the operation by Enrico N. Cuneo of an automobile service for the transportation of passengers, baggage and empress between Jackson and Cook's station and the intermediate points of Pine Grove, Aqueduct, Pioneer Station, Barton's and Antelogo, and

IT IS HEREBY ORDERED that a certificate of public convenience and necessity for such a service be, and the same hereby is granted to Enrico N. Cuneo, subject to the following conditions:

- 1- Applicant herein shall file with the Railroad Commission his written acceptance of the certificate horein granted within a period of not to exceed ten (10) days from date hereof; shall file, in duplicate, tariff of rates and time schedules within a period of not to exceed twenty (20) days from date hereof, such tariff of rates and time schedules to be identical with those attached to the application herein; and shall commence operation of said service within a period of not to exceed thirty (30) days from date hereof.
- 2- The rights and privileges herein authorized may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.
- 3- No vehicle may be operated by applicant herein unless such vehicle is owned by said applicant or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.

4- For all other purposes the offective date of this order shall be twenty (20) days from the date hereof.
