## OPINION and ORDER

Community Investment Company, Inc., has petitioned the Railroad Commission for an order approving the sale and transfer by it to John B. Auld of an operating right for an automobile service for the transportation of passengers between Burbank and Hollywood, and John B. Auld has applied for authority to purchase and acquire said operating right, and to hereafter operate thereunder, the sale and transfer to be in accordance with an agreement marked Exhibit "A", which exhibit is attached to the application herein and made a part thereof.

The consideration to be paid for the property herein proposed to be transferred is given as \$5000, all of which sum is said to represent the value of the equipment involved, no value being claimed for the operating right.

The operating right herein proposed to be transferred was granted to Community Investment Company, Inc., by the Railroad Commission in its Decision No.13005, dated January 9, 1924, and issued on Application No. 9622. In that decision the Railroad Commission declares as follows:

<sup>\*\*\*\*\*</sup>that public convenience and necessity require the operation by the Community Investment Company. Inc., of an automobile stage line as a common carrier of passengers over and along the following route:

"Beginning at the junction of Hollywood Boulevard and Highland Avenue; thence north in Highland Avenue to Ventura Boulevard and northerly to its junction with the Dark Canyon Road and thence northerly and westerly over said road to Olive Street, continue in Olive Street to its junction in Tenth Street and returning by the same identical route."

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

IT IS HEREBY ORDERED that the above entitled application be, and the same hereby is granted, subject to the following conditions:

- 1- The consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission or any other rate fixing body as a measure of value of said property for rate fixing, or any purpose other than the transfer herein authorized.
- 2- Applicant Community Investment Company, Inc., shall immediate withdraw tariff of rates and time schedules on file with the Commission covering service, certificate for which is herein authorized to be transferred. Such withdrawal to be in accordance with the provisions of General Order No.51.
- S- Applicant John B. Auld shall file immediately, in duplicate, in his own name, a tariff of rates and time schedules covering service between Hollywood and Burbank, which rates and time schedules shall be identical with the rates and time schedules filed with the Railroad Commission by Community Investment Company, Inc., or rates and schedules satisfactory in form and substance to the Railroad Commission.
- 4- The rights and privileges herein may not be sold, leased, transferred nor assigned, nor service thereunder discontinued, unless the written consent of the Railroad Commission to such sale, lease, transfer, assignment or discontinuance has first been secured.
- 5- No vehicle may be operated by applicant John B. Auld unless such vehicle is owned by said applicant or is leased under a contract or agreement on a basis satisfactory to the Railroad Commission.
