East Bay Water Company asks permission to sell the fol-

lowing described real property :-

I.

All that certain real property situate, lying and being in the City of Oakland, County of Alameda. State of California, and described as follows, to-wit;-

All that certain real property situate, lying and being in the City of Richmond, County of Contra Costa, State of California, and described as follows, to-wit;-

Lot Number Twenty-seven (27) in Block Number Seventytwo (72) as delineated upon that certain map entitled, "Amended Map of the City of Richmond, being a portion of Lot No. 54 of the final partition of the San Pablo Rancho, Contra Costa County, Cal., surveyed and delineated by H.D. Jerret, C.E., January, 1905, " recorded on the 31st day of March, 1905, in the office of the County Recorder of the County of Contra Costa, State of California.

III.

All that certain real property situate, lying and being in the City of Cakland, County of Alemeda, State of Califormia, and described as follows, to-wit;-

COMMENCING at the most Southerly corner of that certain piece or parcel of land containing One (1) acre, conveyed by East Bay Water Company to Paul E. Magerstadt by deed dated January 18, 1922, and recorded January 23, 1922, in Vol. 124 of Miscellaneous Records, page 411, Alameda County Records, said point of commencement being on the Southwesterly boundary of that certain tract of land conveyed by Ellen H. Chabot to the Contra Costa Water Company by deed dated April 14, 1885, and recorded June 13, 1885, in Liber 288 of Deeds, page 221, Records of Alameda County, California, and running thence from said point of commencement North 36°00° East One hundred (100) feet: thence South 56°00° East Six Hundred sixty and 30/100 (660.30) feet: thence South 36° 45° East One hundred twenty-three and 62/100 (123.62) feet: thence South 53° 15' West One Hundred (100) feet to a point on said Southwesterly line of the above mentioned tract; thence North 36° 45' West One hundred six and 66/100 (106.66) feet: thence North 56° 00' West Six hundred forty-three and 34/100 (643.34) · feet to the point of commencement.

BEING a portion of Plot "F" of the Undivided Mountain and Hill Land of the Ranchos of Vicente and Domingo Peralta, as per Kellersberger's Map of said Ranchos, filed in the office of the County Recorder of Alameda County, California, on the 21st day of January, 1857.

IV.

All that certain real property situate, lying and being in the City of Piedmont, County of Alameda, State of Califormia, and described as follows, to-wit:-

An unnumbered lot in Block Cne (1), as shown on that certain map entitled "Piedmont Acres, Piedmont, Alemeda Col, Cal.", and filed in the office of the Recorder of said Alameda County January 2nd, 1914, said lot being described as follows, to-wit:-

BEING a circle with a diameter of 45 feet, the center of which bears North 42° 14' 58" East 47.50 feet from the point -2-

of intersection of the line dividing Lots Eight (8) and Mine (9) in Block One (1), with the Western line of Sotelo Avenue, as said lots, block and avenue are shown on the map hereinbefore referred to.

Applicant reports that all of the property referred to herein is noncperative and that it is no longer necessary or advantageous to applicant to rotain the ownership thereof.

The Commission has considered the request of applicant, and is of the opinion that this is a matter in which a public hearing is not necessary and that this application should be granted, therefore,

IT IS HEREBY ORDERED that East Bay Water Company be, and it is hereby, authorized to sell the properties described in this order.
