OPINION and ORDER

Southern Pacific Company, a corporation, has petitioned the Railroad Commission for an order authorizing the closing of its agency station at Glenwood on its Coast Division in Santa Cruz County.

Applicant alleges as justification for the granting of the application that the maintenance of the agency station is unremunerative and unnecessary until such time as traffic shall have developed to an extent justifying the reestablishment of an agency station.
