SECOND SUPPLEMENTAL ORDER IN APPLICATION NO. 13429 FIRST SUPPLEMENTAL ORDER IN APPLICATION NO. 13514

The Commission by Decision No. 18037 dated March 2, 1927, in Application No. 18429, authorized Pacific Gas and Electric Company to sell, subject to the provisions of the order in such decision, certain public utility water properties located at Stockton, Oroville, Redding, Willows, Livermore and Dixon.

By its order in Decision No. 18084 dated March 21, 1927 in Application No. 13514 the Commission authorized C. B. Jackson to sell, assign, transfer and set over to the California Water Service Company all of his right, title and interest in and to the contract between

said C. B. Jackson and Pacific Gos and Electric Company dated December 7, 1926 and any amendments and modifications thereto, so that said California Water Service Company may be substituted in the place and stead of C. B. Jackson with respect to said contract, and further authorized Pacific Cas and Electric Company to convey, transfer and set over direct to applicant. California Water Service Company, all the properties, business, rights and privileges included in said contract dated December 7, 1926 and any amendments or modifications thereof.

It occurs to us that Decision No. 18037 in Application No. 13429 and the order in Decision No. 18084, in Application No. 13514 should be modified, as herein provided, therefore,

be, and they are hereby, permitted to substitute California Water Service Company in the place and stead of C.B. Jackson in the opinion and order in said Decision No. 18057 and that paragraph three of the order in said Decision No. 18084 be, and it is hereby, amended so as to permit the transfer of the properties referred to in said paragraph three only under the conditions set forth in Decision No. 18037 dated March 2,1927, as amended,

IT IS HEREBY FURTHER CRDERED that the orders in said Decision No. 18037 and No. 18084 shall remain in full force and effect, except as modified by this Second Supplemental Order in Application No. 13429 and First Supplemental Order in Application No. 13514.
