THIRD SUPPLEMENTAL ORDER

The Commission by Decision No. 12822 dated November 13, 1923, as amended, authorized Southern California Edison Company to execute a mortgage and/or deed of trust to secure the payment of \$250,000,000. of bonds authorized by the stockholders of the company at a meeting held on Sept. 7, 1923 and to secure such additional bonded indebtedness of the company, as its stockholders may authorize. Pursuant to such authority the company executed a trust indenture(mortgage and/or deed of trust) dated October 1, 1923.

In its supplemental petition filed on March 9th in the above entitled matter the company asks permission to execute a supplemental trust indenture for the purpose of enabling the company to secure the listing of its bonds issued or to be issued under the original trust indenture dated October 1, 1923 as legal investments for savings banks in various states. The company has submitted a copy of its proposed supplemental trust indenture. It is of the opinion that the execution of the supplemental trust indenture is for the best interests of the corporation and of the holders of the company's debentures and of the holders of bonds issued or to be issued under the trust indenture dated October 1, 1923.

The Commission has considered the company's request and is of the opinion that it should be authorized to execute a supplemental trust indenture substantially in the same form as that filed in this proceeding on March 9, therefore,

IT IS HEREBY ORDERED that Southern California Edison Company be, and it is hereby, authorized to execute a supplemental trust indenture substantially in the same form as the supplemental trust indenture filed in the above entitled matter on March 9, 1927, provided that the authority herein granted to execute such supplemental trust indenture is for the purpose of this proceeding only, and is granted insofar as this Commission has jurisdiction under the terms of the Public Utilities Act, to authorize applicant to execute said supplemental trust indenture and is not intended as an approval of said supplemental trust indenture as to such other legal requirements to which said supplemental trust indenture may be subject.

IT IS HEREBY FURTHER ORDERED that within thirty days after the execution of said supplemental trust indenture Southern California Edison Company shall file with the Commission a certified copy thereof.
