In the Matter of the Application of BOB ARUTOFF to sell, and SAROP MEMETAROFF and M. ALEX to purchase an automobile freight line operated between Los Angeles and Athens, Cardena, Rosecrans and Wilmington and adjacent territory (milk route).

OPINION and Order

Bob Arutoff has applied to the Railroad Commission for an order approving the sale and transfer by him to Sarop Meketaroff and M. Alex, co-partners, of operating rights for an auto trucking service for the transportation of milk between dairy ranches in the vicinity of Athens, Gardena, Rosecrans and Wilmington and creameries in the city of Los Angeles, and Sarop Meketaroff and M. Alex, co-partners, have applied for authority to purchase and acquire said operating rights and to hereafter operate thereunder, the sale and transfer to be in accordance with an agreement marked Exhibit "A", which exhibit is attached to the application herein and made a part thereof.

The consideration to be paid for the property herein proposed to be transferred is given as \$1800 all of which sum is declared by applicants to be the value of equipment, no value being claimed for intangibles.

The operating rights herein proposed to be transforred were granted to Arutoff by the Railroad Commission in Decisions Nos.15459 and 17889, issued respectively on Applications No.11266 and 13574. In Decision No.16459 the Commission authorized Arutoff to operate a service for the transportation of "milk to Los Angeles from dairy ranches in the vicinity of Athans and Rosecrans, and for no other purpose, over and along the following route:

Leave Los Angeles via South Main Street to Rosecrans Avenue, thence west to Arlington Street, thence south to Olive Avenue, thence west to Perry Station, thence east on Electric Street to Cypress Avenue, thence north to Strawberry Street, thence east to Arlington Street, thence south to Electric Street, thence east to Normandie Avenue, thence west on Electric Street to Western Avenue, thence north to San Pedro Street, thence east to Normandie Avenue, thence south to Wilmington Street, thence east to Figueroa Street, thence south to Walnut Street, thence east to Main Street, thence north to 157 th Street, thence west to Vermont Avenue, thence north to Compton and Santa Monica Road, thence east to South Park Avenue, thence north to 128th Street to South Park Avenue, thence west on 128th Street to South Park Avenue, thence north to 122nd Street, thence west to Main Street, thence north to Los Angeles dairies.

Said route to include all dairy ranches within the boundaries of said route, and within one-half mile outside of said boundaries, excepting, however, the territory east of Figueros Street and south of 182nd Street (Walnut Street), as shown on the outline map attached to the application, marked Amendment to Exhibit "B".

In Decision No.17889 the Commission authorized Arutoff to operate a freight truck service for the transportation of

> "milk and other dairy products between the city of Los Angeles and cortain points in and about the Wilmington district of Los Angeles, as an extension and enlargement of his present authorized service over and along the following routo:

Beginning at Wilmington Boulevard (Main Street) and L Street (Wilmington), north on Wilmington Boulevard to 183rd Street, west to Figueros Street, north to 182nd Street, east to Main Street, north to 165th Street, west to Verment Avenue, north to Redende-Compton Boulevard, east to South Park Avenue, North to Los Angeles, said route to include all dairy ranches within the boundaries of said route and within one-half mile outside of said boundaries, provided, however, that no additional service may be given by applicant north of 182nd Street except as heretofore authorized by Decision No.15459 on Application No.11266; "and

We are of the opinion that this is a matter in which public hearing is not necessary and that the application should be granted.

IT IS HEREBY ORDERED that the above entitled application be and the same hereby is granted, subject to the following conditions:

1- The consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission or any other rate fixing body as a measure of value of said property for rate fixing, or any purpose other than the transfer herein authorized.

2- Applicant Bob Arutoff shall immediately unite with applicants Sarop Meketaroff and M. Alex in common supplement to the tariffs on file with the Commission, applicant Arutoff on the one hand withdrawing, and applicants Meketaroff and Alex on the other hand accepting and establishing such tariffs and all effective supplements thereto.

3- Applicant Arutoff shall immediately withdraw time schedules filed in his name with the Railroad Commission and applicants Meketaroff and Alex shall immediately file, in duplicate, in their own names, time schedules covering service heretofore given by applicant Arutoff, which time schedules shall be identical with the time schedules now on file with the Railroad Commission in the name of applicant Arutoff or time schedules satisfactory to the Railroad Commission.

4- The rights and privileges herein authorized may not be sold, leased, transferred nor assigned, nor service thereunder discontinued, unless the written consent of the Railroad Commission to such sale, lease, transfer, assignment or discontinuance has first been secured.

5- No vehicle may be operated by applicants Meketaroff and Alex unloss such vehicle is owned by said applicants or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.
