

Decision No. 19126.

In the Matter of the Application of City of Culver City, California, for permission to construct a grade crossing over the right-of-way of PACIFIC ELECTRIC RAILWAY COMPANY

at the intersection of Sawtelle Boulevard and Culver Boulevard, in the City of Culver City, California.

The City Council of the City of Culver City, County of Los Angeles, State of California, filed the above entitled application with this Commission on the 28th day of November, 1927, asking for authority to construct a public street known as Sawtelle Boulevard at grade across the double track Del Rey Line of Pacific Electric Railway Company, in the City of Culver City as hereinafter set forth. Said Pacific Electric Railway Company has signified by letter that it has no objection to the construction of said crossing at grade, and it appears to this Commission that the present proceeding is not one in which a public hearing is necessary; that it is neither reasonable nor practicable at this time to provide a grade separation or to avoid a grade crossing with said tracks at the point mentioned in this application, and that this application should be granted, subject to the conditions herein-

IT IS HEREBY ORDERED that permission and authority be and it is hereby granted to the City Council of the City of Culver City, County of Los Angeles, State of California, to construct Sawtelle Boulevard at grade across the double track Del Rey Line of Pacific Electric Railway Company at the location as shown by the map attached to the application.

The above crossing shall be identified as Crossing No. 6F-11.22.

Said double track crossing shall be constructed subject to the following conditions and not otherwise:

(1) The entire expense of constructing the crossing shall be borne by applicant. The cost of maintenance of that portion of said crossing outside of lines two (2) feet outside of the outside rails shall be borne by applicant. The maintenance of that portion of the crossing between lines two (2) feet outside of the outside rails shall be borne by Pacific Electric Railway Company. No portion of the initial cost herein assessed to applicant for the construction of said crossing shall be assessed by applicant, in any manner whatsoever, to the operative property of Pacific Electric Railway Company.

(2) The crossing shall be constructed of a width not less than fifty (50) feet and at an angle of about eightyfive (85) degrees to the railroad and with grades of approach not greater than five (5) per cent; shall be constructed substantially in accordance with Standard No. 3 as specified in General Order No. 72 of this Commission; shall be protected by two (2) suitable crossing signs and shall in every

way be made safe for the passage thereon of vehicles and other road traffic.

(3) An automatic flagman shall be installed and maintained for the protection of said double track crossing. Said automatic flagman shall be of a type and installed in accordance with Standard No. 3 in General Order No. 75 of this Commission. The entire cost of installing said automatic flagman shall be borne by the applicant and the cost of maintaining it thereafter shall be borne by Pacific Electric Railway Company.

(4) Applicant shall, within thirty (30 days thereafter, notify this Commission, in writing, of the completion of the installation of said crossing.

(5) If said crossing shall not have been installed within one year from the date of this order, the authorization herein granted shall then lapse and become void, unless further time is granted by subsequent order.

(6) The Commission reserves the right to make such further orders relative to the location, construction, operation, maintenance and protection of said crossing as to it may seem right and proper and to revoke its permission if, in its judgment, the public convenience and necessity demand such action.

The suthority herein granted shall become effective.
