OPINION AND ORDER DENYING PETITION FOR KEHEARING

On petition for rehearing made by respondents, this proceeding was reopened for the purpose of oral argument as to our findings that the addition of Note 2 to Item 10 and Note 4 to Item 20 of Pacific Freight Tariff Eureau Tariff 30-H, C.R.C. 366 and similar items published in joint tariffs issued by F. W. Gomph, Agent, and in the tariffs of the individual carriers, was not justified. Oral argument was presented by all interested parties on November 15, 1926.

Now, upon further consideration of Decision No.17175 dated July 31, 1926, and of the record in the above-entitled proceeding in the light of the oral argument, and after consideration of the petition for rehearing, and each and every allegation thereof, and being now of the opinion that the petition for rehearing should be denied and that our original decision No. 17175 should be affirmed.--

NOW, THEREFORE, IT IS HEREBY ORDERED that said Decision No. 17175, dated July 31, 1926, be, and the same is hereby affirmed.
