SUPPLEMENTAL ORDER

By Decision No. 19568 dated April 9th, 1928, the Commission authorized California Water Service Company to issue \$6,254,000.00 of thirty year first mortgage five percent bonds due April 1, 1958, subject among others to the condition that none of said bonds may be delivered until the Commission has authorized the California Water Service Company to execute a mortgage and/or deed of trust to secure the payment of said bonds.

On April 25th the California Water Service Company filed with the Commission a revised copy of its proposed mortgage and/or deed of trust. We have examined such instrument and find the same

to be in satisfactory form and are of the opinion that its execution should be authorized, subject to the provisions of this order; therefore,

IT IS HEREBY ORDERED that California Water Service Company be, and it is hereby, authorized to execute a mortgage and/or deed of trust substantially in the same form as the copy of the proposed mortgage and/or deed of trust filed with the Commission on April 25, 1928, provided that the authority herein granted to execute a mortgage and/or deed of trust is for the purpose of this proceeding only and is granted insofar as this Commission has jurisdiction under the terms of the public utilities act and is not intended as an approval of said mortgage and/or deed of trust as to such other legal requirements to which said mortgage and/or deed of trust may be subject.

IT IS HEREBY FURTHER ORDERED that Decision No. 19467 dated March 12, 1928; Decision No. 19540 dated March 31, 1928; and Decision No. 19568 dated April 9, 1928 shall remain in full force and effect, except as to such provisions of said decisions as may be inconsistent with this supplemental order.

IT IS HEREBY FURTHER ORDERED that California Water Service Company shall file with the Railroad Commission within thirty (30) days after the execution of the mortgage and/or deed of trust herein authorized, two certified copies of such instrument.
