OPINION and ORDER

In this application Union Pacific Stage Company, a corporation, asks for authority to discontinue service over a part of the route it was authorized to operate an automotive passenger stage service by an order of the Railroad Commission issued on Application No.15474, to extend its service to a point described as Salt Pools and to file with the Commission new tariffs and time schedules covering the service proposed herein.

Applicant declares that operation for two seasons has shown that the service given to the north beyond Harmony Borax Works has not proved attractive because of the similarity of the territory between the Borax Works and Salt Creek Crossing, present terminal of the route, with the rest of the route, with no added features of interest to tourists and the "general traveling public." In the new territory proposed to be served beyond (south of) Devil's Golf Course are what are described as "Salt Pools", a point of scenic interest, but recently discovered.

The tariff changes proposed are of minor importance, with little effect on the traveling public.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

Union Pacific Stage Company is hereby placed upon notice that "operative rights" do not constitute a class of property which should be capitalized or used as an element of value in determining reasonable rates. Aside from their purely permissive aspect, they extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be changed or destroyed at any time by the state which is not in any respect limited to the number of rights which may be given.

IT IS HEREBY ORDERED that Union Pacific Stage Company be and is hereby authorized to discontinue operation of its automotive passenger stage service between Harmony Borax Works and Salt Creek Crossing and intermediate points, and

THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREBY DECLINES that public convenience and necessity require the operation by Union Pacific Stage Company of an automotive stage service for the transportation of passengers and baggage between Devil's Golf Course and Salt Pools and intermediate points, and

IT IS HEREBY FURTHER ORDERED that a certificate of public convenience and necessity for such a service be and the same is hereby granted to Union Pacific Stage Company, a corporation, subject to the following conditions:

1- That the service herein authorized shall be operated from November 1st of each year to April 30th of each year in connection with and as part of the service now being conducted by the applicant herein; that the certificate of public convenience and necessity herein granted shall not be considered as a separate operating right but as an extension of the right now held by applicant.

2- Applicant shall file its written acceptance of the certificate herein granted within a period of not to exceed ten (10) days from date hereof.

3- Applicant shall file, in duplicate, within a period of not to exceed twenty (20) days from the date hereof, tariff of rates and time schedules, such tariffs of rates and time schedules to be identical with those attached to the application herein, or rates and time schedules satisfactory to the Railroad Commission, and shall commence operation of said service within a period of not to exceed thirty (30) days from the date hereof.

4- The rights and privileges herein authorized may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.

5- No vehicle may be operated by applicant herein unless such vehicle is owned by said applicant or is leased by it under a contract or agreement on a basis satisfactory to the Railroad Commission.

For all other purposes the effective date of this order shall be twenty (20) days from the date hereof.
