ORDER

East Bay Water Company, a corporation, having made application to the Railroad Commission for permission to sell the properties described in this order and it appearing that said properties are a part of the properties which the Commission, by Decision No. 20503 dated November 19, 1928, authorized the company to sell to the East Bay Municipal Utility District and said district having advised the Commission that it has no objection to the sale of the properties described herein, and the Commission being of the opinion that this is not a matter in which a public hearing is necessary and that this application should be granted, therefore

IT IS HEREBY ORDERED that East Bay Water Company, a corporation, be and it is hereby authorized to sell the following described real properties:

l. a. The consideration for the transfer of the above property shall not be urged before this Commission or any public body as a finding of value for rate-fixing or for any purpose other than authorized herein.
