WE TO Decision No. 20605 BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA In the Matter of application of Holton Inter-Urban Railway Company for an order authorizing construction at grade of rail-Application No. 15242. road tracks across Ferm Avenue and Fourth Street in the City of Holtville, County of Imperial, State of California. BY THE CORNESION: ORDER Holton Inter-Urban Railway Company, a corporation, filed the above entitled application with this Commission on the 6th day of December, 1928, asking for authority to construct a spur and wye track at grade coross Fourth Street and a wye track at grade across Fern Avenue in the City of Holtville, County of Imperial, State of California, as hereinafter set forth. The necessary franchise or permit has been granted by the City Council of said City for the construction of said crossings at grade. It appears to this Commission that the present proceeding is not one in which a public hearing is necessary; that it is neither reasonable nor practicable at this time to provide grade separations or to avoid grade crossings at the points mentioned in this application with said Fourth Street and Fern Avenue and that this application should be granted subject to the conditions hereinarter specified, therefore, IT IS HEREBY ORDERED that permission and authority be and it is hereby granted to Holton Inter-Urban Railway Company to construct a spur track and a wye track at grade across Fourth -1-

Street and a wye track at grade across Fern Avenue, in the City of Holtville, County of Imperial, State of California, at the locations hereinafter particularly described and as shown by the map (L.A. Division Drawing No. B-830) attached to the application. Description of Crossings FERN AVENUE - Beginning at a point in the westerly line of Fern Avenue distant northerly thereon 90.00 feet from the northwesterly corner of the intersection of Ferm Avenue and Fourth Street, thence southeasterly along a curved line concave to the southwest, having a radius of 382.25 feet, a distance of 100.00 feet to a point in the easterly line of Fern Avenue, distant northerly thereon 50 feet from the northeasterly corner of the intersection of Fern Avenue and Fourth Street. FOURTH STREET - Beginning at a point in the northerly line of Fourth Street distant easterly thereon 30 feet from the northeasterly corner of the intersection of Fern Avenue and Fourth Street; thence southeasterly along a curved line, concave to the southwes easterly along a curved line, concave to the southwest, having a radius of 382.25 feet, a distance of 95 feet to a point in the southerly line of Fourth Street distant easterly thereon 80.00 feet from the southeasterly corner of the intersection of Fern Avenue and Fourth Street; also beginning at a point in the aforesaid northerly line of Fourth Street distant easterly thereon 51.00 feet from the northeasterly corner of the intersection of Fourth Street and Tern Avenue; thence southeasterly through a Number 12 switch and along a curved line, concave to the southwest, having a radius of 382.25 feet, a distance of 100.00 feet to a point in the southerly line of Fourth Street, distant easterly thereon 92.00 feet from the southeasterly corner of the intersection of Fern Avenue and Fourth Street. Said crossing of Fourth Street shall be identified as Crossing No. 49-709.4-C. Said crossing of Fourth Street shall be constructed subject to the following conditions, and not otherwise: (1) The entire expense of constructing the crossing, together with the cost of its maintenance thereafter in good and first-class condition for the safe and convenient use of the public, shell be borne by applicant. (2) Said crossing shall be constructed equal or superior -2to type shown as Standard No. 2, in General Order No. 72 of
this Commission and shall be constructed without superelevation
and of a width to conform to that portion of said street now
graded, with the tops of rails flush with the roadway and with
grades of approach not exceeding four (4) per cent; shall be
protected by a Standard No. 1 crossing sign, as specified in
General Order No. 75 of this Commission, and shall in every
way be made suitable for the passage thereover of vehicles
and other road traffic.

B. Said crossing of Fern Avenue shall be constructed
subject to the following conditions, and not otherwise:

(1) Said crossing shall be constructed at the sole
expense of applicant and so that grades of approach not exceed-

- (1) Said crossing shall be constructed at the sole expense of applicant and so that grades of approach not exceeding four (4) per cent will be feasible in the event that the construction of roadway along said Fern Avenue shall hereafter be authorized and so that said crossing may be made suitable for the passage thereover of vehicles and other road traffic.
- (2) This order is made upon the express condition that Fern Avenue is not now actually constructed and open to travel at the point of crossing and said order shall not be deemed an authorization for the construction of an opening of said street to public use across said railroad track.
- C. All of the crossings herein shall be subject to the following conditions:
- (1) Applicant shall remove the track shown in yellow on the map (L.A. Division Drawing No. B-830) attached to the application and shall repair the streets to conform to the remainder thereof.
- (2) Applicant shall, within thirty (30) days thereafter, notify this Commission, in writing, of the completion of

the installation of said crossings.

- (3) If said crossings shall not have been installed within one year from the date of this order, the authorization herein granted shall then lapse and become void, unless further time is granted by subsequent order.
- (4) The Commission reserves the right to make such further orders, relative to the location, construction, operation, maintenance and protection of said crossings, as to it may seem right and proper, and to revoke its permission if, in its judgment, the public convenience and necessity demand such action.

The authority herein granted shall become effective on the date hereof.
