## OPINION and ORDER OR SUPPLEMENTAL APPLICATION

In a supplemental application Motor Coach Company has petitioned for an order of the Commission authorizing it to reroute its auto stages over what it describes as its Orange Avenue route. It seeks authority to operate over and along the following route:

Commencing at the northeast corner of the intersection of Pine Avenue and East Ocean Boulevard, in the City of long Beach, thence north along Pine Avenue to Broadway, thence east along Broadway to Alamitos Avenue, thence northerly along Alamitos Avenue to Orange Avenue, and thence north along Orange Avenue to Sixty-eighth Street; returning along the same route to the intersection of Broadway and Alamitos Avenue, thence southerly along Alamitos Avenue to East Ocean Boulevard, and thence west on East Ocean Boulevard to the point of beginning.

The proposed rerouting will not entail any change in feres or schedules. The City Council of the City of Long Beach has approved the change as is shown by copy of resolution adopted by said City Council attached to the application herein and made a part thereof.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted. Therefore,

IT IS HEREBY ORDERED that Motor Coach Company be and it is hereby authorized to operate its Orange Avenue line over and along the following route:

Commencing at the northeast corner of the intersection of Pine Avenue and East Ocean Boulevard, in the City of Long Beach, thence north along Pine Avenue to Broadway, thence east along Broadway to Alamitos Avenue, thence northerly along Alamitos Avenue to Orange Avenue, and thence north along Orange Avenue to Sixty-eighth Street; returning along the same route to the intersection of Broadway and Alamitos Avenue, thence southerly along Alamitos Avenue to East Ocean Boulevard, and thence west on East Ocean Boulevard to the point of beginning,

provided that the order herein shall not be construed as a grant of an additional operating right, but only as authority to operate over a different route than that laid down in Decision No.20954 for its Orange Avenue line.
