In the Matter of the Application of

formerly The Associated Telephone Com-  
pany, and of Associated Telephone Com-  
pany, Home Telephone Company of Covina,  
Huntington Beach Telephone Company,  
Redondo Home Telephone Company, Laguna  
Beach Telephone Company and Santa Mon-  
ica Bay Telephone Company for an order  
of the Commission (a) authorizing Asso-  
ciated Telephone Company Ltd. to acquire  
all, or substantially all, the outstand-  
ing capital stock of each of the other of  
said applicants; (b) authorizing each of  
said other applicants to transfer and  
convey all its property and assets to  
Associated Telephone Company Ltd. and (c)  
authorizing Associated Telephone Company  
Ltd., for the purpose of acquiring the  
stock and properties of said other ap-  
plicants, to issue preferred and common  
stock and to assume the liabilities of  
said other corporations existing at the  
date of their acquisition, and for the  
purpose of discharging or refunding cer-  
tain of such liabilities, to issue and  
sell preferred stock.

FIRST SUPPLEMENTAL ORDER

WHEREAS, the Railroad Commission, by Decision No. 21268,  
dated June 21, 1929, in the above entitled matter, made its order,  
among others, authorizing The Associated Telephone Company to issue  
and sell, at not less than \$23.00 per share, on or before October 1,  
1929, 106312 shares of its preferred and 126638 shares of its  
common stock; and

WHEREAS, the Commission has been advised in a supplemental petition filed in the above entitled matter on August 26th, that The Associated Telephone Company, under date of August 20, 1929, amended its Articles of Incorporation, and, among other things, changed its corporate name to Associated Telephone Company Ltd; and

WHEREAS, the Commission has been asked to give its consent and approval to the issuance by Associated Telephone Company Ltd, pursuant to the order in Decision No. 21268, dated June 21, 1929, of the shares of preferred and common stock authorized by said order to be issued; and

WHEREAS, the Commission has considered the request of applicants and believes that such request should be granted, as herein provided, therefore,

IT IS HEREBY ORDERED, that the Opinion and Order in Decision No. 21268, dated June 21, 1929, be, and the same are hereby modified, by substituting the name Associated Telephone Company Ltd., for The Associated Telephone Company, wherever said name of The Associated Telephone Company appears in said Opinion and Order.

IT IS HEREBY FURTHER ORDERED that the Opinion and Order in Decision No. 21268, dated June 21, 1929, shall remain in full force and effect, except as modified by this First Supplemental Order.
