O P I N I O N

Suisun and Green Valley Telephone Company in this proceeding, seeks authority to file and make effective rates and charges for extension bells and extension gongs.

A public hearing in this matter was held in San Francisco by Examiner Williams on October 1, 1929, at which place and time the matter was submitted for decision.

Leslie Gordon, Manager, and witness for applicant, testified that subscribers to applicant's telephone service had been allowed to connect privately owned extension bells and gongs to company lines without initial or recurring charges therefor. The present application is for authority to make installation and monthly charges for this service. Applicant proposes to purchase the present privately owned extension bells and gongs or to replace them at the option of the subscribers and to apply the requested rates. The application rates are the same as are generally in effect in California for similar service. It appears that the recurring charges should be on a yearly rather than on a monthly

basis and the Order following will so provide.

No objection to the granting of the authority requested was received at the hearing and it appears that the application should be granted.

O R D E R

Suisun & Green Valley Telephone Company having requested permission to file and make effective certain rates for supplemental equipment, a public hearing having been held, the matter having been submitted and now being ready for decision,

The Railroad Commission of the State of California hereby finds as a fact that the rates and charges proposed by applicant and contained in the application herein are just and reasonable and should be made effective.

Basing its Order on the above finding of fact and on such facts as are contained in the Opinion preceding this Order,

IT IS HEREBY ORDERED that Suisun & Green Valley Telephone Company be, and the same hereby is authorized to charge and collect, on and after November 1st, 1929, the rates set forth in Exhibit "A" attached hereto and made a part of this Order, provided; that such rates and charges are submitted for filing with the Railroad Commission of the State of California, in the manner and form prescribed in General Order No. 68, on or before ^{act 25, 1929} October 25, 1929.

For all other purposes the effective date of this Order shall be twenty (20) days from and after the date hereof.
