ORDER OF DISMISSAL

On September 12, 1929, the Commission entered its order instituting an investigation upon its own motion into the accounting methods, practices, rules, regulations, keeping of records, intercorporate relations, compliance with uniform classification of accounts and the annual reports of the companies mentioned above. Subsequently thereto, there was filed with the Commission Application No. 16054, in which the several companies, except American Construction Company and American States Public Service Company, asked permission to consolidate their properties under the corporate name of the American

States Water Service Company of California.

By Decision No. 21939, dated December 23, 1929, as amended by Decision No. 21972, dated December 31, 1929, the Commission authorized the companies therein mentioned to enter into a consolidation agreement, which agreement was executed and the companies and their properties consolidated into a new corporation under the name of the American States Water Service Company of California.

The record in Application No. 16054 makes it unnecessary, in our opinion, to proceed with the hearing in Case No. 2754 and therefore that proceeding should be dismissed.

IT IS HEREBY ORDERED that Case No. 2754 be, and the same is hereby, dismissed.
