
Decision No. 22831

In the Matter of the Application of NATURAL GAS CORPORATION OF CALIFORNIA, a corporation, for a certificate of public convenience and necessity authorizing it to exercise rights and privileges under franchises which it contemplates securing from the Cities and Towns and Counties herein named, and also authorizing it to construct plants and systems in such Cities, Towns and Counties for the purpose of serving gas to the public for light, heat, power and other purposes for which gas is now or may hereafter be used.

## THIRD SUPPLEMENTAL ORDER

In Decision No. 22564, dated June 23, 1930, this Commission made its order granting certain certification and authorization to Natural Gas Corporation of California and among other things ordered:

- (1) That Natural Gas Corporation of California shall file with this Commission on or before July 31, 1930, copies of all contract-agreements under which applicant will receive or purchase the liquid gas that it proposes to use in this service.
- (4) That Natural Gas Corporation of California shall file with this Commission, on or before July 31, 1930, a stipulation, duly executed upon authority of its Board of Directors, agreeing that if and when, at any time, this Commission desires to investigate any of the costs or revenues incident to this service, including the cost of liquid gas, applicant will produce and present to the Commission at the latter's request, all of the details that make up such costs or revenue, including a break-down of the production costs which make up the contract price for the purchase of such liquid gas.

Applicant herein having on July 30, 1930, requested the Commission for an extension of time of thirty (30) days from the limit of time mentioned in the Commission's Decision No. 22564, dated June 23, 1930, within which to comply with Conditions Nos. 1 and 4 in the above entitled proceeding, the Commission did order in its Supplemental Decision No. 22723 that such time limit be extended to August 30, 1930.

Applicant herein having again on August 27, 1930, requested the Commission for a further extension of time of thirty (30) days from the limit of time mentioned in the Commission's Decision No. 22723, dated August 4, 1930, within which to comply with Conditions Nos. 1 and 4 of Decision No. 22564, and it appearing to the Commission that this request is reasonable and should be granted, therefore,

IT IS HEREBY ORDERED that the time limit of compliance with the Conditions Nos. 1 and 4 of Decision No. 22564 of June 23, 1930, and contained in the above opinion, be and it is hereby extended to September 30, 1930.

In all other respects this Commission's Decision No. 22564 of June 23, 1930, in this matter shall remain in full force and effect.
