BY THE CONCUSSION -

OPINION and ORDER on FIRST SUPPLIMENTAL APPLICATION

This is a supplemental application by Pacific Electric Railway Company, a corporation, to change routing of what is described as Route No.3 of its bus line operations in the City of Glandale, which service was authorized by Decision No.22435. It is proposed to operate over and along the following route, no change in fares or schedules being involved:

Commencing at the intersection of Lake Street and Allen Avenue; north on Allen Avenue to Flower Street, east on Flower to Sonora Avenue; thence northerly on Sonora Avenue to the Glendale Airport; thence easterly along road through Glendale Airport to Grand View Avenue; north on Grand View Avenue to Glenwood Road; east on Glenwood Road to Concord Street; south on Concord Street to Broadway; east on Broadway to Brand; south on Brand to Colorado Street; vast on Colorado to Verdugo Road; thence north on Verdugo Road to Broadway, from which point service is to divide, one half operating north on Verdugo Road and Chevy Chase to Linda Vista and the other half operating east on Broadway to Wilson, thence northerly along Wilson, Vallejo, Brodrick, Holly Drive, Merrill Avenue to Glenoaks and easterly along Glenoaks Boulevard to Ashburton Place. Returning reverse of the going trip to the intersection of Sonora Avenue and Flower Street; thence south on Sonora to Lake and west on Lake to Allen Lyenue, point of beginning.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted. The proposed change has been approved by the City Council of the City of Glondale, as shown by letter attached to and made part of the supplemental application herein.

IT IS HEREBY ORDERED that Pacific Electric Railway
Company, a corporation, be and it is hereby authorized to
operate motor coach service over and along the following route
in the City of Glendale, instead of over the route described
as route No.3 in Decision No.22435:

Commencing at the intersection of Lake Street and Allen Avenue; north on Allen Avenue to Flower Street, east on Flower to Sonora Avenue; thence northerly on Sonora Avenue to the Glendale Airport; thence easterly along road through Glendale Airport to Crand View Avenue; north on Crand View Avenue to Glenwood Road; east on Glenwood Road to Concord Street; south on Concord Street to Broadway; east on Broadway to Brand; south on Brand to Colorado Street; east on Colorado to Verdugo Road; thence north on Verdugo Road to Broadway, from which point service is to divide, one half operating north on Verdugo Road and Chevy Chase to Linda Vista and the other half operating east on Broadway to Wilson, thence northerly along Wilson, Vallejo, Brodrick, Holly Prive, Merrill Avenue to Glemoaks and easterly along Glemoaks Boulevard to Ashburton Place. Returning reverse of the going trip to the intersection of Sonora Avenue and Flower Street; thence south on Sonora to Lake and west on Lake to Allen Avenue, point of beginning.

In all other respects Decision No.22435 is to remain unchanged.
