OPINION and ORDER

Tanner Motor Tours, Ltd., is asking by this application to change its "Tour No.5, Los Angeles-Riverside-Orange Empire Tour" so as to permit the operation of a service to Mount Roubidoux, a point within the limits of the City of Riverside, and which it may serve under authority of the certificate authorizing Tour 5.

It appears, however, that it is not possible for applicant to operate its sightseeing equipment over the roads to the summit of the mountain. It is proposed to use limousines for the mountain trip and to exact a fare of \$1. for the extra service, making the total fare \$6. as against a charge of \$5. for the present tour to Riverside with Mount Roubidoux excluded. Cray Line Motor Tours Co., which is owned by the applicant herein, includes Mount Roubidoux in its tour, using limousines in its mountainous trip from Riverside proper, and charges \$6 for the full trip.

We are of the opinion that this application should be granted. It does not appear to be a matter in which a public hearing is necessary.

IT IS HEREBY ORDERED that Tanner Motor Tours, Ltd. be and it is hereby authorized to reroute its Tour No.5 (Los Angeles-Riverside-Orange Empire Tour) over and along the following routes

Leaving Los Angeles via Whittier Boulevard through Fullerton, Placentia, Santa Ana Canyon and Corona to Riverside, thence to Mount Rubidoux, returning via Valley Boulevard through Ontario to Upland, thence Foothill Boulevard to San Dimas, thence to El Monte and thence by Valley Boulevard to Los Angeles, or vice versa,

the trip to Mount Roubidoux from Riverside proper to be optional.

IT IS HEREBY FURTHER ORDERED that applicant shall within thirty (30) days from the date hereof reissue or amend its tariff now on file with the Commission so as to show that the fare of \$5.00 therein named for Tour No.5 (Los Angeles-Riverside-Orange Empire) does not include a trip to Mount Roubidoux and to provide an additional round trip fare of \$6.00 for a tour similar to the present Tour No.5 but including the mountain trip.
